THIS SCOPE OF SERVICES AGREEMENT ("SOSA") is made and entered into is made and entered into this ______ day of ______, 2024, by and between the BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO (the "County"), and Beacon Communications, LLC, authorized to do business in Colorado (the "Consultant"). The County and Consultant are sometimes collectively referred to herein as the "Parties."

WHEREAS, the County has an active Master Services Agreement (the "MSA") with the Consultant to perform services for the County governed and executed through Scope of Services Agreements (SOSA); and

WHEREAS, the County would like Beacon to design and install an audio-visual system for the Douglas County Justice Center DA23 Quad Divisible Conference Room, and

WHEREAS, the County has budgeted and appropriated the necessary funds to satisfy the financial obligations set forth in this SOSA.


NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the parties agree as follows:

- 1. **MASTER SERVICES AGREEMENT:** This SOSA is subject and subordinate to the terms and conditions specified in the MSA, executed between the County and Consultant.
- 2. SCOPE OF WORK: All services described in <u>Exhibit 1</u>, attached hereto and incorporated herein, shall be performed by Consultant.
- **3. MAXIMUM CONTRACT LIABILITY:** Any other provisions of this SOSA notwithstanding, in no event shall the County be liable for payment under this for any amount in excess of Two Hundred Five Thousand Three Hundred Thirty-Eight and Seventy-Four Cents (\$205,338.74). The County is not under obligation to make any future apportionment or allocation to this SOSA. Any potential expenditure for this SOSA outside the current fiscal year is subject to future annual appropriation of funds for any such proposed expenditure.
- 4. TERM: It is mutually agreed by the parties that the term of this SOSA shall commence as of 12:01 a.m. on the 6th day of February 2024 and terminate at 11:59 p.m. on the 1st day of February 2025. This SOSA and/or any extension of its original term shall be contingent upon annual funding being appropriated, budgeted, and otherwise made available for such purposes and subject to the County's satisfaction with all products and services received during the preceding term.
- 5. COUNTY EXECUTION OF AGREEMENT: This SOSA is expressly subject to and shall not be or become effective or binding on the County, until execution by all signatories of the County.

System Scope of Work

Functional Summary DA23 Conference Room:

- Audio Visual system allows presentations, audio, and video calls within all 4 conference rooms in a separate or combined state.
- Audio Visual system allows a person to control the meeting from the wall mounted touch panel. Video Teams calls will be controlled thru the owner furnished PC via wireless keyboard & mouse.
- Audio Visual system allows participants to view meetings remotely by joining a team's call. System also allows participants to share content remotely while on a call or share content from within the room.
- Ability to present in person via HDMI wall plate in each room. Presenters have ability to share audio and video.
- Remote attendees have ability to view and listen to presenters and presentations while joining a meeting remotely and not be seen or heard by in room & remote participants.
- User interface is intuitive and user friendly.
- Wireless microphone for flexible meetings.

Functional Description DA23 Conference Room:

In this proposal Beacon Communications is proposing an audio-visual system for Douglas County Justice Center DA23 Quad Divisible conference room. This conference space will incorporate the latest audio-visual technology available today. This proposed system will allow Douglas County easier expansion for future needs and create an up-to-date system using an audio and video over IP solution. The main advantage of a video over IP system is scalability by allowing easy expandability to accommodate more devices and sources at any point in the future. The system will have the ability for 4K video if there is ever a need in the future.

The quad divisible room will have the ability to be set up in any configuration desired by the end user. Each of the 4 spaces will have 2 (two) 86" commercial 4k displays, 2 (two) pan tilt auto following cameras, in ceiling microphone arrays, in ceiling speakers for sound reinforcement, and 1 (one) HDMI wall input plate for presentations. Additionally, one set of wireless microphones which includes 1 handheld microphone, and 1 lavalier microphone can be utilized within the space. Each room can function individually on Teams calls, presentations, or audio calls. Also, the rooms can be combined in any fashion and have the same functions as previously stated. Control of the rooms will have a user friendly 10" wall mounted touch panel to control volume, cameras, video routing system on/off. Beacon will work with the DC Justice Center team on the programing and how the touch screen user interface functions within the system. Partition sensors will be installed to eliminate the confusion of room setup and automatically route audio and video signals in the proper rooms.

The idea of having 2 displays and 2 cameras in each of the rooms is to allow the end user flexibility within the space based on table and chair setup due to the many types of scenarios and configurations. The displays will mirror what if being presented.

For teams video calls the owner furnished PC's will be utilized. Each room will have its own PC which will be mounted behind the display for ease of servicing. The locations of the cameras will be determined by DC and Beacon.

The audio-visual equipment will reside in a new AV equipment rack which will be located down the hall in the IDF.
