## Emergency Management

- Douglas County announces DougCoAlert to keep community informed during emergency situations**



*Information courtesy of the Douglas County Sheriff's Office:* Public safety officials in Douglas County announced today that **DougCoAlert** is now available to all residents, replacing the previous CodeRed system. Even if you were signed up for the previous system, you must register with the new platform to get emergency alerts.

**DougCoAlert** is a free service that allows individuals to receive notifications sent from state and local authorities to stay informed on potentially hazardous situations involving natural disasters (wildfires, floods, severe storms), evacuations and shelter-in-place orders, law enforcement activities, and public safety emergencies. The switch to **DougCoAlert** allows residents to receive alerts via phone, text and email. [Visit our webpage to learn more about the system and to register.](#)

- Staff facilitated and participated in a regional Wildfire Initiated Community Conflagration (WICC) workshop. This workshop focused on Alert, Warning, and Evacuation during conflagration fires.
- Numerous Emergency Services and Incident Management Team staff attended the Colorado Wildfire and Incident Management Academy. They completed training coursework in preparation for incident command and fire operations positions.
- Staff continue preparing for an upcoming Continuity of Operations exercise with the Sheriff's Office.



## Open Space and Natural Resources

- **A gateway to the outdoors and history of Douglas County** - You know that in Douglas County, we are



committed to continuously improving and protecting our open spaces. At a Business Meeting on Tuesday, Jan. 13, the Board of County Commissioners unanimously voted to allocate funding to the High Line Canal Conservancy (HLCC) for improvements to the Origins Trailhead. The County will contribute \$450,000 toward the project from the Parks, Trails, Historic Resources and Open Space fund, with HLCC providing an additional \$150,000 in matching funds. - **Volunteer Clean-up Day** - On Tuesday, January 20th, OSNR volunteers and staff completed a cleanup along the Front Range Trail south of Columbine Open Space. The team removed debris left by the original property owner, including long planks of lumber, chain-link fencing, wire, cement blocks, metal tubing, and miscellaneous trash.



The abandoned materials posed a hazard to wildlife, particularly the chain-link fence, and were located near a riparian area that is a common travel corridor for mule deer, elk, and beaver. The team filled one open-top dumpster, significantly improving site safety and environmental conditions.

- **Volunteer Weed Warriors** - OSNR has a dedicated group of volunteers called the Weed Warriors. Every week throughout the summer and fall, the Weed Warriors go out into the field to mitigate noxious weeds including mullein, Canada thistle, musk thistle, knapweed, dalmatian toadflax. The Weed Warriors were also working at Sandstone Ranch Open Space on Thursday, January 22<sup>nd</sup>, mitigating mullein before the snow arrived.

### **Projects or Grants:**

- **Intellectual and Developmental Disabilities (IDD) Supportive Housing Grant** - Douglas County is accepting applications for the IDD Housing with Supportive Services Grant from January 16-30. The grant will fund one new supportive housing project that expands safe, stable housing and person-centered services for individuals with IDD in Douglas County.

One project will receive \$2.5 million over three years, with annual payments not to exceed \$833,333, subject to contract terms and performance. After applications are reviewed, a funding recommendation will be forwarded to the Board of County Commissioners for consideration.

- **Douglas County Youth Initiative (DCYI)** - The DCYI Advisory Board held its first meeting of the year on January 12 to discuss the upcoming year and highlighted the following events:

## Public Works

### Activity Report January 12 – January 23, 2026

#### Active Projects ([Cone Zone Webpage](#))

- [County Line Road Widening and Reconstruction](#) – Construction on County Line Road began in September 2025. Beginning Tuesday, Jan. 6, 2026, County Line Road will be fully closed for approximately 100 days between Clarkson Street and the U-Haul business access. This closure is required for crews to safely import, move and place large quantities of dirt, equal to filling 40,000 washing machines, at Lee Gulch. The fill operations, which are a key component of the widening and reconstruction work, will level out the roadway by removing the dip at Lee Gulch, improving drainage, driver line of sight and overall public safety. Since 2019, Douglas County has worked with partners to advance the final design, acquire right-of-way, and prepare utility relocation design for a major water line located within the project area. Douglas County is partnering with the Denver Regional Council of Governments, City of Littleton, and City of Centennial to fund the project.

- **I-25 Douglas County Monument Signs** – Cushing Terrell has begun producing construction plans for both the north and south monument signs. They have submitted the application to CDOT and are following up in its status. Once the County has CDOT approval, the project will move into the construction phase. Approval is expected to take several months.
- [Hilltop Road \(Legend High School to Crest View Drive\) Improvements Project](#) – For segment 1 of this



project, the construction began on April 16, 2025, and the contractor began implementing public notifications on message boards. This is the first of three projects planned over the next few years to reconstruct and widen the Hilltop Road and Singing Hills Road corridors. The project has a 16-month completion date and is anticipated to be finished in September 2026. Phase 2 of Construction is anticipated to begin in 2027; and will take 9 to 12 months to construct. Phase 3 of construction is anticipated to begin in 2029 (pending funding); and will take 12 to 18 months to construct.

There have been questions from citizens about the new roundabout construction at the intersection of Crestview Dr and Village Rd on Hilltop Rd, which will eliminate the existing two-way stop-controlled intersection. Here is the map: [Roundabout Rendition/Map](#).

- [Pine Creek and Highway 67 Culvert Replacement Project](#) - Two culverts on Pine Creek Rd and three culverts on Douglas County Highway 67 need to be replaced. The existing storm culverts vary in size from 36" diameter to 48" diameter and are made of metal. We are anticipating that this work will occur Fall 2025 – Spring 2026. These culvert replacements will have roadway impacts and travelers to the area should expect long delays.



- **Highlands Ranch Pkwy Reconstruction, Broadway to Burntwood** - Olsson submitted the 90% design, the geotechnical report, and a cost estimate for the project. County staff is providing feedback and revisions

to the plans and bid documents. The project is planned to bid before April and construction will start summer of 2026.

- **Jones Road** – Matrix Design Group was selected as the design consultant for the design of the Jones Road project. The project includes asphalt paving of the roughly 3-mile road as well as drainage improvements. The project will be constructed in phases. A concept design has been selected, and the team is working towards the final design of the first phase.

- **Grigs Road Paving Project – Phase 2** - RS&H was selected as the design consultant for phase 2 of the Grigs Road project. Phase 2 will start where phase 1 ends, near the East-West Trailhead Parking Lot and will continue north onto the existing concrete road. The project includes realignment of the road, drainage improvements, a parallel pedestrian trail, and asphalt paving. A virtual open house is being developed to share the concept designs and solicit feedback from the public. Survey and geotechnical work continue. This project is scheduled to be constructed in 2027.



- **2023 Bannock LID** - The design consultant, TST, is working on the design, with a preliminary design expected by the end of the year. County staff have reviewed the initial roadway design and provided feedback. The consultant is continuing the roadway design and beginning the drainage design. Once the preliminary design is complete, financing will be executed, and plans will be prepared for bidding. (Design work performed in advance of finalizing financing will be reimbursed to the County by the lender as part of the construction loan.)



- **Quebec and Park Meadows Dr Intersection Improvements** – Basis Partners has submitted the concept designs and cost estimates, and County staff met in mid-December to review the designs. The concept design includes improvements from C470 to the lighted intersection south of Park Meadows Dr. The first phase of work is planned for 2026 and may include retiming of signals and upgrades to signs and striping. Basis is also working on a proposal to provide final design for a larger project that includes reconfiguring the lanes, median, and sidewalks as well as reconstruction of the pavement continuing to Palomino Pkwy.

- **2025 Pavement Management Projects**

- The **2026 Sidewalk Repair Project** was bid on December 9th. Chato's Concrete, LLC was the apparent low bidder with a bid of \$2,279,120.00. This is 9% below the engineer's estimate. The contract is scheduled to go to the Board for approval on January 13th and work is expected to begin in March.
- The **2026 Asphalt Overlay Project** bid on December 2nd. The apparent low bidder was Martin Mareitta Materials, Inc. with a bid of \$10,230,041.55 which was 13% below the engineer's estimate. The contract will go to the Board for approval on January 13th and work is expected to begin in May.
- The **2026 Guardrail Repair Project** bid on December 16th. The apparent low bidder submitted a bid package that was found to be insufficient; the next low bidder is Cruz Construction. The bid amount from Cruz Construction was \$150,090.00 which was 25% under the engineer's estimate. The contract is scheduled to go to the Board for approval on January 13th and work will begin shortly after.





- 2023 Spring Canyon LID** – The design consultant, TST, is nearing the end of preliminary design and will continue into final design. The CDPHE approval process for the proposed lift station continues. CORE and Black Hills Energy continue to work on the designs for electric and gas services. The county has received rough construction cost estimates as well as a proposal for final design work and the project is still on schedule for mid-2026 construction bidding. TST will begin reaching out to property owners in December to discuss design considerations. (Design work performed in advance of finalizing financing will be reimbursed to the County by the lender as part of the construction loan.)

- Planning Area 1, Kellytown East (DV2023-463)** - A GESC Permit was issued for the construction of an outdoor RV and boat storage center. (see far right)
- Sterling Ranch Filing #7-C** - Three Sons is installing storm sewer (DV #2024-410). (see near right)
- The Canyons Subdivision Filing #5** - WW Clyde is backfilling sanitary sewer pipe (DV #2021-287). (see far right)
- Pinery Center Parkway – King Soopers** - Fiore & Sons is installing trench drain and splash block (DV #2018-453). (see near right)
- Meridian Office Park Filing #1 – Sarah’s Place** - Thoutt Brothers and Nikon are installing sidewalk and storm sewer pipe (DV #2021-440). (see far right)
- Piney Lake Trails Subdivision** - Claystone Construction is installing sanitary sewer infrastructure (DV #2022-517). (see near right)
- The Fields Subdivision Filing #1** - Liberty Infrastructure is installing storm sewer infrastructure (DV #2024-322). (see far right)






- **Event Spotlight:** On February 1 at 5:00 p.m., the Douglas County Fairgrounds is scheduled to host a political rally for gubernatorial candidate Victor Marx in the Event Center. The event is being organized directly by the campaign and is planned for a minimum attendance of approximately 500 people, with the potential to reach upwards of 1,500 based on the standing-room capacity and day-of interest. As a less typical event type at the Fairgrounds, the rally presents greater variability in expected attendance and operational needs. Fairgrounds staff are coordinating logistics, crowd management, and facility readiness in advance, with the potential for media presence. The event reflects the fairgrounds' flexibility in accommodating a diverse range of rentals while maintaining operational preparedness.

## Information Technology

### Completed Projects

- Copilot Use/Rollout Strategy** - The M365 Copilot Use Strategy Project has successfully reached its go-live milestone and transitioned to operational support as of December 19, 2025. This achievement includes configuring and validating the Copilot environment, securing licenses, delivering foundational training, launching the Copilot Champions program, and establishing a scalable rollout and support model. Moving forward, HR and the AI Center of Excellence will lead adoption efforts, while the Infrastructure Team manages licensing and technical support.
- Onsite Wastewater Treatment Services (OWTS) Archived Septic Permit Upload Initiative** - The OWTS Archived Septic Permit Upload Initiative went live on December 3, 2025, adding over 8,000 historical septic permit records to the County’s Geospatial application. This new searchable map layer allows staff and the public to easily locate properties and access legacy permit documents online. The effort improves transparency and provides quick access to historical data, enhancing service for citizens and Public Health staff.

### Project Update

- WorkSMART Program**
  - WorkSMART is Douglas County’s **Enterprise Resource Planning (ERP) modernization program**, designed to replace our legacy JDE financial system of 23 years with a modern, platform that supports how the County operates today—and into the future.
  - The WorkSMART program continues to make strong progress. Tailored Procedure Document (TPD) working sessions are now complete, marking a key milestone in validating future-state processes, workflows, security, and system navigation with business subject matter experts. These sessions ensured that the new Finance and Budget system reflects operational needs and identified issues early—before go-live.
  - With TPDs being finalized, the program is now transitioning to our next major milestone, Conference Room Pilot (CRP) sessions!! CRP is a hands-on, iterative validation phase where end-to-end business scenarios are tested in Dynamics 365 to confirm system configuration, data readiness, integrations, security, and overall performance. Findings from each session will be reviewed and refined, ensuring the solution is aligned with Douglas County’s requirements before moving into later testing, training, and deployment phases.
  - This progression from design validation to system-wide testing represents a critical step in delivering a reliable, well-aligned solution that supports efficient, countywide financial operations.

### Commissioner Administrative Meeting - January 12, 2026

- **Boards and Commissions Reappointments:** The Board of County Commissioners reviewed and acted on reappointments to multiple county advisory boards and commissions. The Board directed staff to prepare a formal resolution, to be presented at a future business meeting, to complete reappointments for the Cultural Council, Historic Preservation Board, and Open Space Advisory Committee. In addition, The Board agreed to schedule a Fair Board meeting for Commissioners and board members only during the first quarter, directed staff to research whether the Fair Board’s 21-member size is capped by resolution, and reviewed internal and external board assignments, requesting an administrative update to reflect a previously changed E-470 representative.

**Motion:** The Board reappointed members to new terms on the Cedar Hill Cemetery District Board, DD Mill Levy Advisory Board, Fair Board, Parks Advisory Board, Planning Commission, and Water Commission.

- The Board met in executive session to discuss security protocols. Staff were directed to implement the measures discussed in coordination with the Sheriff's Office.
- **Water Resource Management and Cooperation:** The Board met with Castle Rock Water, Highlands Ranch Water, and Parker Water & Sanitation to discuss long-term water planning, conservation, and regional cooperation. Providers agreed that outdoor irrigation accounts for 40–50% of summer water use and offers the greatest conservation opportunity, and they requested county consideration of development regulations promoting water-efficient and native landscaping. The providers expressed willingness to assist smaller districts upon request, citing benefits such as lower costs, access to renewable water, infrastructure rehabilitation, and improved emergency reliability; Parker Water also proposed a wholesale renewable water supply model for smaller districts. The Board offered legislative support through the county's state lobbyist, directed providers to review the draft 2050 Water Plan with their governing boards and submit formal input, and discussed a potential future Douglas County Water collaborative entity to support ongoing coordination and policy development.
- **Community Development Regulatory Updates:** The Board of County Commissioners reviewed three Community Development regulatory updates and unanimously directed staff to proceed on all items. The Board supported amendments to streamline site plan requirements for single-family attached residential developments and directed staff to release the proposed changes for a 30-day referral period. The Board also reviewed proposed amendments to align large family home daycare regulations with state law by removing the Use by Special Review process and directed staff to schedule public hearings before the Planning Commission and the Board of County Commissioners. Lastly, the Board reviewed the county's existing administrative review process for electric vehicle charging stations and directed staff to bring forward a resolution at a future business meeting to formally affirm the county's efficient review procedures in compliance with state law.

### **Commissioner Call with State Lobbyists - Executive Session - January 14, 2026**

- The Board of County Commissioners voted to enter executive session to receive confidential updates and provide strategic direction to the county's state lobbyists regarding ongoing legislative negotiations during the 2026 General Assembly session. Following the executive session, the Board discussed the early and highly fluid nature of the 2026 legislative session, noting that many bills remain under active negotiation prior to initial committee hearings. Commissioners expressed strong confidence in the county's state lobbying team, affirming they are well-positioned to advocate effectively on Douglas County's behalf during this period of change. The Board emphasized the importance of continued coordination and monitoring as legislation advances, and conveyed appreciation for the lobbyists' professionalism and strategic engagement on complex policy matters.

### **Commissioner Work Session - January 20, 2026**

- **Community Services:** The Board reviewed progress and next steps for transit, housing stability, and public safety initiatives. The Link On-Demand transit program surpassed 61,000 rides and will expand into Parker and Stonegate in April 2026 and Castle Rock in late summer/early fall 2026, with a projected \$6.3 million countywide cost, including \$400,000 requested from Castle Rock and \$250,000 from Parker, and \$2 million in pending RTD funding requests. Staff were directed to continue efforts to establish Douglas County as the direct recipient of approximately \$2 million annually in new federal transit funds, a process expected to take 12–18 months. The HEART program reported zero encampments and 60 permanent housing placements in 2025, with plans to add two mental health navigator positions in 2026. Commissioners also supported advancing a human trafficking and online child safety education initiative, expanded faith-based

outreach, a February “Douglas Has HEART” donation campaign, and planning for a Douglas County Initiative Summit to strengthen cross-program collaboration.
