I. EXECUTIVE SUMMARY

Girls Rugby Colorado (GRC), a 501(c)(3) non profit organization, requests a fee waiver in the amount of \$200 for the use of Pinery Park grass field for their practices on October 2, 9, 16, and 23, 2024. This is for 10 players and 2 coaches.
