### **UPDATES**

#### **Buck and Rail Fence**

Park Rangers at Rueter-Hess Reservoir recently installed an additional 90 feet of buck-and-rail fencing along the Rosie Rueter Trail at the Incline. This enhancement aims to protect fragile vegetation, promote the growth of native plants, and support a thriving ecosystem for local wildlife.

In keeping with Douglas County's commitment to sustainability and resource protection, all materials used for the fencing were reclaimed from older fences previously decommissioned on other County properties.

Staying on designated trails is not just encouraged, it's essential. Offtrail hiking can lead to the creation of "social trails," which damage sensitive environments, accelerate erosion, and compromise the

natural balance of the park. By respecting trail boundaries and supporting preservation efforts like this one, to help ensure the long-term health of Rueter-Hess and its natural beauty for generations.



#### Fall Fishing



As autumn settles over Rueter-Hess Reservoir, the fishing remains steady, with walleye continuing to be the primary catch. While many of the walleye reeled in exceeded the 16 to 20-inch catch-and-keep limit, anglers remain enthusiastic about the consistent action on the water. Shoreline fishing is also picking up as the water temperature starts to lower. Paddle season will be coming to a close on November 16th but fishing will still remain open from the fishing dock or on the shoreline until ice forms on the reservoir.



### OCTOBER 2025 RUETER-HESS OPERATIONAL UPDATES REPORT

Park ranger staff participated in the October 2<sup>nd</sup> Parks celebration at Highlands Heritage Regional Park by providing kids with casting lessons, fish coloring, and information about Rueter-Hess reservoir.

On October 23<sup>rd</sup>, staff attended the County sponsored Emergenetics for the Minds Training to maximize professional relationship efforts. Staff continue to complete on-line training, updates to operational guidelines, manuals, and other administrative responsibilities.

Octobers mild weather allowed park rangers to get a head start on finalizing the end of the season mowing and trimming of the Rueter-Hess trails, fishing access, parking lots, and picnic areas before snowfall. Staff inspected trails for major safety hazards and filled holes, cut branches, and removed large rocks. The County owned rental boats received maintenance ensuring they are ready for next season. Non-essential buoys were pulled and cleaned for next year's use. The dock removal process and logistics are being planned and will commence over the next few weeks.




