- Council evaluation discussion, Jeff Garcia: Asks Council preferred approach to handling remaining evaluation contract with Steadman Group.

- Omni Shares general evaluation plan/approach.
- Will align work with Steadman evaluation approach and assess where things can be streamlined and simplified.
- Dedicated evaluation team ready to troubleshoot issues and address questions

## Discussions and Decisions

- **SE2 Campaign Update: Rodger Hudson**
  - Roger Hudson voiced issues with the SE2 campaign as it currently stands. Hoping for a campaign that is less Denver-centric and more tailored to the County.

- County Communications dept and Council leadership are working on the campaign and managing the relationship with SE2.
- Final update coming from Caroline Frizzel County Communications director at the next meeting.
- **Hard Beauty Hospital/Jail In-Reach: Savannah Putnam**
  - Skyridge program moving forward well.
  - Some challenges emerging with scope of work and Douglas County Jail program.
    - Only Racquel has been cleared to enter the facility. DCJ has requested HardBeauty use tablets for peer outreach rather than allowing them in the jail. This does not align with the approved plan the Council funded or Hard Beauty's proven approach to recovery support services.
    - Retired Chief Kevin Duffy and Division Chief Jason Kennedy are meeting to advocate to address the issue directly with DCJ leadership and Chief Phil Domenico.
- **DCCF Designated Fund Update: Kirsten Swanson**
  - DCCF is finalizing the MOU, will review at July meeting.
  - DCCF looking for 5 people to serve as expert review team for incoming applications. Must have behavioral health and local knowledge.
  - Volunteers: Meil Reuman, Kevin Duffy, Laura Ciancone, Katie Craft, Nicole Martin, Ruby Richards, Jennifer Eby, Savannah P
  - *Action item: Omni to convene group. Omni to find non-discloser/conflict of interest form for group to sign.*
- **Valley Hope Proposal: Becky Brassan and Kortney Poire**
  - Review of ask. Valley Hope of Parker seeking \$100K for their patient essential fund to support people entering the Parker sober living facility with financial barriers. Award would assist at least 90 patients in their assistance to sober living.
  - Questions/discussions:
    - Concerns with ensuring the funding supports primarily Douglas County residents. Discussion ensues around the transient nature of most patients and the importance of supporting unhoused people with SUDs in the County. Valley Hope explains the process patients go through to be eligible for these funds which requires confirmation of financial duress. Council discusses whether or not to withhold funds specifically for Dougco residents only. Decides this is not supportive of the overall goal to reduce SUDs in the county.
    - Valley Hope will track # of uninsured/Medicaid recipients; Dougco residents served; location of sober living
