I. REQUEST

A. Request

Approval of a transfer of ownership for a tavern liquor license for Campus Lounge Backcountry, LLC d/b/a Campus Lounge Backcountry.

B. Project Description

An application for a liquor license transfer was submitted on December 23, 2024. A tavern liquor license must comply with Section 44-3-414 of the Colorado Liquor Code. Under a tavern liquor license, alcoholic beverages must be sold for consumption on the premises.

C. Location

The site is located at 10989 Sundial Rim Road in Highlands Ranch, south and west of Backcountry Drive.

II. CONTEXT

On December 23, 2024, staff received an application to transfer the existing liquor license. Submitted background checks show relevant criminal history; therefore, the application is presented to the Liquor Licensing Authority for a decision on the license transfer request.

This site was originally approved with project file SP2006-077 and allows for restaurant uses as part of the SIP approval. The business hours of alcohol sales are Thursdays 4 pm to 10 pm, Fridays 4 pm to 11 pm, and Saturdays 4 pm to 10 pm. There will be between 7 and 10 part-time employees. The premises will be closely monitored by the manager on duty.

III. AUTHORITY

Authority to act on this transfer of ownership application is provided under Section 44-3-303 of the Colorado Liquor Code.

IV. PUBLIC NOTICE AND INPUT

In accordance with the Colorado Liquor Code, public notice is required to be posted on the site and published in a local newspaper. No public comment has been received.

V. STAFF ANALYSIS

A tavern liquor license may be approved upon the finding that:

- Notice was posted and published.
Staff Comment: Notice was posted on January 31, 2025 and published on January 30, 2025.
- The licensee is of good moral character.
Staff Comment: Background investigations are complete and show relevant criminal history.
- The licensee has legal possession of the premises.
Staff Comment: The applicant has provided the lease agreement showing legal possession of the premises.
- The premises is suitable for the requested license.
Staff Comment: The property is zoned as Planned Development (PD) and a Site Improvement Plan (SIP) was approved for the use.

VI. STAFF ASSESSMENT

Staff has evaluated the liquor license in accordance with the Colorado Liquor Code. Should the Authority find that the requirements for the liquor license transfer are met, the following proposed condition shall be considered for inclusion in the motion to approve the license:

1. Prior to issuance of the license, the State of Colorado License shall be approved and provided to Douglas County.

BACKCOUNTRY SUNDIAL HOUSE FOOD AND
BEVERAGE SERVICE AGREEMENT

This Food and Beverage Service Agreement for the Backcountry Sundial House (Agreement), dated 18th day of December, 2024, is between the Backcountry Association, Inc. located at 10989 Sundial Rim Road, Highlands Ranch, Colorado 80126 (Association) and Campus Lounge Backcountry, LLC located at 2715 17th St. Unit 103, Denver, CO 80211 (Operator). The Association and Operator may be referred to individually as “Party” or collectively as “Parties” in this Agreement.

WHEREAS:

1. The Backcountry Sundial House (Sundial House) is located at 10989 Sundial Rim Rd., Highlands Ranch, Colorado 80126, in Douglas County, Colorado, and is owned by the Association. The Sundial House is the Association’s community center as depicted in Attachment A. The main floor has a welcome desk, on-site staff offices, a kitchen, Pikes Pub, Lounge, Community Room, restrooms and the Outdoor Terrace. The basement has several rooms and offices, including a storage room with enclosed storage and desks. The Association converted the kitchen from the original developer’s Demonstration Kitchen to allow for commercial food service and has made food service available to its Members¹ and their Related Users² since approximately 2017.
2. The Sundial House is an amenity for the exclusive use of Association Members and their Related Users. As a result, the general public is not invited into the Sundial House.
3. The Association and Operator desire to make Food and Beverage Service, including alcoholic beverage service, available to Members and their Related Users at the Sundial House.
4. The Association and Operator understand that on or before the date Operator begins selling alcoholic beverages at Pikes Pub pursuant to this Agreement, Operator must obtain the necessary permits and/or Tavern Liquor License from Douglas County and the State of Colorado Department of Revenue Liquor Enforcement Division (Licensing Authorities) to commence performance of Operator’s obligations hereunder. Association’s current food and beverage service provider has a contractual obligation to transfer the Tavern Liquor License it currently holds to the Association.

Association and Operator, in consideration of the mutual covenants and agreements set forth herein, agreed as follows:

1. Term. Agreement will begin on or about 1 December 2024 and have a five-year term. The Parties anticipate that Operator will begin its Food and Beverage Service in January 2025. Notwithstanding the foregoing, Operator acknowledges that the current Food and Beverage Service Provided may not vacate the Sundial House premises subject to this Agreement prior to such date; in such event, the start date for this Agreement and the obligations hereunder shall be extended accordingly.

¹ A Member is established by Section 2.58 of the Amended and Restated Subassociation Declaration for Backcountry Association, Inc. of Highlands Ranch Community Association, Inc. (Declaration).

² Related User is defined in Declaration Section 2.72 and includes persons who are part of the Member’s household and a Member’s guests and invites.

2. Premises: Operator will enjoy the exclusive use of the Sun Dial House Kitchen, Pikes Pub and storage areas as specifically identified and described in Exhibit A. All such areas described in Exhibit A are referred to as “Premises.”
3. Grant of Exclusive Rights. Association appoints Operator to provide Food and Beverage Service at Pikes Pub for Association Members and their Related Users. Operator will provide Food and Beverage Service at and from the Sundial House Kitchen and Pikes Pub as described in Exhibit B. Association grants to Operator the right to provide such Food and Beverage.
4. Tavern Liquor License Rights.
 - a. Association further grants Operator the right to apply for and obtain a Tavern Liquor License, including a temporary license, and permits required by Colorado and Douglas County authorities. Costs associated with the application or transfer of the license will be borne by Operator. Association will use its best efforts to facilitate the transfer of the current Tavern Liquor License to Operator pursuant to its contract with the current concessionaire, which Operator has reviewed.
 - b. Operator shall renew the Tavern Liquor License and permits as required by licensing authorities during the term of this Agreement and the expenses associated with such renewal will be paid by the Operator.
 - c. Upon termination of this Agreement, Operator will transfer the Tavern Liquor License and other licenses and permit(s) to sell alcoholic beverages to Association or Association’s designee, to the extent such transfer is permitted by the licensing authorities, and the expenses associated with such transfer will be reimbursed or paid by the transferee.
5. Association Responsibilities.
 - a. Association shall keep all the improvements upon the premises, including but not limited to, structural components, interior and exterior walls, floors, ceilings, roofs, sewer connections, plumbing, wiring, and glass in good working order. Association will perform maintenance and repairs of such improvements at Association's expense, except expenses for damages caused by the acts of the Operator or Operator's employees or agents which will be charged to Operator. Operator shall notify the Association of conditions requiring repair and the Association shall accomplish said repair within a reasonable time. Operator is responsible for frequently removing and cleaning service items, disposing of trash, and cleaning surfaces in the Sundial House throughout and at the close of Operator’s hours of operation each day in a manner and standard applicable to the food industry.
 - b. Association will provide Operator and its employees, agents, and suppliers access to Association property.
 - c. Association will support the Food and Beverage Service Operator offers Members and their Related Users through communication channels the Association currently utilizes and without the Association incurring additional costs to include email notices and signs within the community.

- d. Association will communicate Operator's Food and Service offerings to Members and their Related Users renting Sundial House facilities/spaces.

6. Operator Responsibilities.

- a. Operator will provide Food and Beverage Service Thursday through Saturday of each week beginning at 4:00PM each day and until the Sun Dial House closes at 10:00PM on Thursdays and 11:00PM on Fridays and Saturdays. Operator's employees, staff and agents shall start a minimum of 30 minutes prior to the beginning of each day's service. Days and hours of operation may change only upon the mutual written agreement of the Parties. The Parties will not unreasonably withhold agreement to such change.
- b. Operator will provide Food and Beverage Service on additional days and for special and lifestyle events upon mutual written agreement of the Parties³. The Parties will not unreasonably withhold agreement to such change.
- c. Operator will supply its own inventory of food and beverages and cookware, equipment, glassware, serving ware, utensils, condiments, paper products and other items commonly used in connection with the operation of the Food and Beverage Service. Operator is responsible for all the costs of providing the Food and Beverage Service and is responsible for payments of suppliers of such inventory and equipment. Operator may charge Members and their Related Users a fee for its Food and Beverage service.
- d. Operator will operate the Food and Beverage Service in accordance with all applicable local, state and federal laws, ordinances, regulations and policies.
- e. Operator will obtain and maintain all required licenses and permits and shall pay all required local state and federal taxes arising from the Food and Beverage Service.
- f. Operator is responsible for and will pay any fines or penalties arising out of its operation of the Food and Beverage Service, including any attorneys' fees or costs accruing against or incurred by the Association.
- g. Operator is responsible for the hiring and payment of its employees, staff and agents, including payment of all applicable taxes, fees and worker's compensation insurance. Operator shall provide service levels that include appropriate levels of staffing to support the needs of Members and their Related Users. Operator will use due care to supervise its employees and agents.
- h. Operator shall at all times keep the general area in which the Food and Beverage Service are to be performed clean and free from accumulation of waste materials, grease or rubbish caused by performance of the Food and Beverage Service. Operator is responsible for ongoing and continuous cleaning and clearing of all surfaces that come in contact with food, including tabletops and floors, commensurate with standards in the food service

industry during its hours of operation. Operator shall also clean after closing Service at the end of each day to prepare the Sundial House for the next day's Service. Cleaning includes daily cleaning of surfaces, furniture, floors, bathroom surface cleaning and trash pickup.

- i. Operator will promptly take all action(s) necessary to maintain the Food and Beverage Service in good standing.

- 7. Communication. Operator shall meet at least monthly with the Association's General Manager or his/her designee to review all items and topics germane to the Service. Each party may request additional meetings and the other party will use best efforts to schedule and attend such meetings.

- 8. Merchandise and Products. Operator may use Association's pictures, drawings, designs, brand names and trademarks (Intellectual Property) upon the written approval of the Association's Board of Directors. This permission to utilize Association's Intellectual Property is limited to merchandise and products sold exclusively and solely at or from the Sundial House.

- 9. Monthly Fee.
 - a. Operator shall pay Association 10% of gross sales generated by the Operator's Service and merchandise and product sales, unadjusted for any expenses, but excluding sales tax and tips (Monthly Fee). The Monthly Fee is due and payable without notice by the 15th of the month for the previous month's sales, delivered to the Association at 10989 Sundial Rim Rd., Highlands Ranch, Colorado 80126, Attn: General Manager. Operator must provide a detailed calculation of the Monthly Fee with each payment, in Xcel format, as more fully described in Exhibit C and agrees that the Association has the right to audit Operator's records upon request. Monthly Fee(s) outstanding ten (10) days after payment is due shall be subject to an interest charge of 1.5% per month of the outstanding amount due and will continue to accrue until the Monthly Fee(s) and interest has been paid in full. Operator shall attach a copy of income reported to the State for Backcountry location only for backup purposes.

 - b. The Monthly Fee payable during the initial two (2) months (January and February 2025) of operation shall be waived. The Monthly Fee payable during the third (3rd) and fourth (4th) months (March and April 2025) of operation shall be at the reduced rate of 5% of gross sales unless otherwise mutually agreed by the Parties in writing.

- 10. Assignment. Operator shall not assign this Agreement or any part therein.

- 11. Use of Premises. Operator does not have exclusive use of the Sundial House and understands the Association and its Members and their Related Users may utilize the building at times for rentals, events, meetings or other purposes. Operator shall not use the Premises in a manner prohibited by the Association, laws of the United States or the State of Colorado or by the ordinances of Douglas County and shall neither permit nor suffer any disorderly conduct, noise, or nuisance that will disturb any persons occupying adjacent premises or other portions of the Sundial House. Further, Operator shall not use the Premises for any purpose which would render the insurance thereon void or the insurance risk more hazardous.


12. Alterations to Premises. Operator shall not alter the Premises without written consent of the Association. The Parties anticipate that Operator plans to remove the Pike Peaks countertop to install equipment, install additional televisions in Pikes Pub and professionally installed string lighting on the Outdoor Terrace in locations mutually agreed upon by the Parties.
13. Publicly Displayed Signs. Operator acknowledges the Association’s governing documents prevent changing the name of the Sundial House and Pikes Pub, however, the Association, in its sole discretion, may allow Operator to install a sign to reasonably identify Operator’s name, services and products. The Parties intend for Operator to display its name on the Kitchen wall below the oven vent; an area that separates the Kitchen and Community Dining areas.
14. Insurance. Operator’s commercial general liability policy and other liability policies must include contractual liability that applies to the hold harmless and indemnification clauses of this Agreement and name the Association and Association's Directors, Officers and management company. Operator shall submit a valid Certificate(s) of Insurance evidencing the required coverages, including the insurance carriers' names, policy numbers, and coverage expiration dates. Operator shall name Association and Association's directors, officers and community manager(s) as Additional Insured parties under the required insurance policies. Operator will provide at least ten (10) days written notice to the Association of any policy cancellations or significant changes affecting any of the required insurance policies. Association will provide Operator with proof of liability insurance for the Sundial House.
15. Indemnification. Operator agrees to indemnify, defend, and hold harmless Association and Association's directors, officers and managers against all liabilities, costs and expenses, including reasonable attorneys' fees, arising out of or in connection with all acts, including negligent, reckless and intentional acts, of Operator or Operator's employees, contractors, subcontractors, consultants, or anyone for whom the Operator is liable.
16. Association's Entry and Other Rights. Operator's use of the Sundial House is non-exclusive. The Association shall have the right and authority to enter the Sundial House and Premises at any hour. Operator acknowledges the Sundial House’s spaces, rooms, offices and restrooms are open to and will be used by Association and its Members and their Related Users at the discretion of the Association, including during Operator’s operating hours. The Association will, from time to time and at any time, utilize and rent portions of the Sundial House to other parties.
17. Termination.
 - a. Either Party may terminate this Agreement without cause upon delivery of written notice of termination to the other Party at least sixty (60) days in advance of the date which the Agreement is to be terminated. Upon termination, Operator must cease Service, pay all monies owing Association, remove its property and employees from the Sundial House and Premises, return all Association property in its possession (e.g., keys) and pay for any damages Operator caused or causes through the date that the move-out and return of property is complete.
 - b. Termination for Cause. In the event Operator violates or breaches a term of this Agreement, the Association shall deliver written notice of the breach to the Operator. Upon notice of breach, the Operator must cure the default within ten (10) business days from the date of delivery of the written notice unless the breach cannot be cured in such time. In such event,

Operator shall commence to cure within 10 days and diligently pursue the cure to completion. The Association's failure to deliver such written notice(s) does not constitute a waiver of the Association's rights under this section.

- c. Upon Operator's failure to cure a breach within the required time period or upon Operator's breach of this Agreement after (3) prior opportunities to cure during the term of this Agreement, the Association may terminate this Agreement and, if so terminated, Operator shall immediately surrender the Sundial House, cease Food and Beverage Service, pay all monies owing Association, immediately remove its property and employees from the Sundial House, return all Association property in its possession (e.g., keys) and pay for any damages Operator caused or causes on the date listed in the written notice of breach. Further, Operator shall be responsible for damage it caused or causes through the date that the move-out and return of property is complete.
18. Casualty. If the property or the Sundial House is destroyed in whole or in part by fire, the elements, or other casualty and if, in the sole opinion of the Association, they cannot be repaired within ninety (90) days from said casualty and the Association informs the Operator of said decision or if the Premises are materially damaged and the Association informs the Operator it does not desire to repair same and desires to terminate this Agreement, then this Agreement shall terminate on the date of such casualty. In the event of such termination, Operator shall immediately surrender the possession of the Premises and Association property to the Association. In such an event, Association shall grant Operator a license to enter the premises at reasonable times to remove Operator's possessions from the Premises.
 19. Attorney's Fees. In the event any dispute arises concerning the terms of this Agreement, the services contemplated hereby or the nonpayment of any sums under this Agreement and the matter is turned over to an attorney or litigation is filed, the party prevailing in such dispute shall be entitled, in addition to other damages or costs, to receive reasonable attorneys' fees and costs from the other party.
 20. Operator's Insolvency. This Agreement is made with the express understanding and agreement that in the event the Operator becomes insolvent, the Association may declare this Agreement terminated, and all rights of the Operator hereunder shall terminate and cease. However, Association may pursue remedies against Operator.
 21. No Partnership, Agency or Joint Venture. Nothing herein contained will be deemed or construed by the parties hereto, or by any third party, as creating the relationship of principal and agent or of partnership or of joint venture or any similar arrangement between Association and Operator.
 22. Third Party Beneficiaries. This Agreement has been made and entered into for the sole protection and benefit of the Parties and their respective successors and assigns and no other person or entity will have any right or action under this Agreement.
 23. Modification. The terms of this Agreement may not be altered or amended unless such alteration or amendment is in writing and signed by both Parties.
 24. Miscellaneous Terms:

- a) No assent, express or implied, to any breach or default of any one or more of the agreements hereof shall be deemed or taken to be a waiver of any succeeding or other breach or default.
- b) Operator shall be allowed to use furniture, fixtures, appliances and storage areas within the Sundial House as identified in Exhibit A.
- c) This Agreement shall be conditioned upon the approval by applicable licensing authorities of Operator's application for a license for the operations contemplated hereunder, and in the event such application is not promptly approved, either party hereunder may immediately terminate this Agreement. Operator must maintain applicable licensing and comply with licensing agency rules and regulations throughout the term of this Agreement.
- d) This Agreement shall be subordinate to all existing and future security interests on the Sundial House.
- e) Operator shall not cause, suffer or permit any mechanics, materialman's, or other liens or encumbrances to attach to or be recorded against any portion of Association's property and shall indemnify and hold harmless Association from and against any and all claims, losses, damages, Association's attorney's fees and costs and injuries of any nature whatsoever resulting from or arising out of any liens or encumbrances.
- f) This Agreement may be executed in counterparts, with each counterpart to constitute an original and all counterparts, taken together, to constitute one and the same agreement.
- g) All notices shall be in writing and be personally delivered or sent by first class mail, postage prepaid, unless otherwise provided by law, to the respective Parties at the address listed in this Agreement.
- h) If any term or provision of this Agreement shall be invalid or unenforceable, the remainder of this Agreement shall not be affected thereby and shall be valid and enforceable to the full extent permitted by law.
- i) This Agreement shall be binding on all parties, their personal representatives, successors, and assigns.
- j) When used herein, the singular shall include the plural.
- k) This Agreement will be interpreted under and governed by the laws of the State of Colorado. Venue for any action arising under this Agreement is Douglas County Colorado.
- l) This Agreement may be executed in counterparts, with each counterpart to constitute an original and all counterparts, taken together, to constitute one and the same agreement.

OPERATING AGREEMENT

This Operating Agreement (“**Agreement**”) of Campus Lounge Backcountry, LLC, a Colorado limited liability company (the “**Company**”), effective as of August 20, 2024 (the “**Effective Date**”), is entered into by Recess Holdco LLC, a Colorado limited liability company, as the sole member of the Company (the “**Member**”).

WHEREAS, the Company was formed as a limited liability company on August 20, 2024 by the filing of a Articles of Organization (the “**Articles**”) with the Secretary of State of the State of Colorado pursuant to and in accordance with the Colorado Limited Liability Company Act and any successor statute thereto, as amended from time to time, and the Colorado Business Corporation Act and any successor statute thereto, as amended from time to time (together, the “**Act**”); and

WHEREAS, the Member agrees that the membership in and management of the Company shall be governed by the terms set forth herein.

NOW, THEREFORE, the Member agrees as follows:

1. Name. The name of the Company is Campus Lounge Backcountry, LLC.
2. Purpose. The purpose of the Company is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and to engage in any and all activities necessary or incidental thereto.
3. Principal Office; Registered Agent.
 - (a) Principal Office. The location of the principal office of the Company shall be as set forth in the Articles, or such other location as the Member may from time to time designate.
 - (b) Registered Agent. The registered agent of the Company for service of process in the State of Colorado and the registered office of the Company in the State of Colorado shall be that person and location reflected in the Articles. In the event the registered agent ceases to act as such for any reason or the registered office shall change, the Member shall promptly designate a replacement registered agent or file a notice of change of address, as the case may be, in the manner provided by law.
4. Member.
 - (a) Member. The Member owns 100% of the membership interests in the Company. The name and the business, residence or mailing address of the Member are as follows:

(b) Additional Members. One or more additional members may be admitted to the Company with the consent of the Member. Prior to the admission of any such additional members to the Company, the Member shall amend this Agreement to make such changes as the Member shall determine to reflect the fact that the Company shall have such additional members. Each additional member shall execute and deliver a supplement or counterpart to this Agreement, as necessary.

5. Management.

(a) Authority; Powers and Duties of the Manager. The management of the Company shall be vested in the Managers (the “**Managers**”). Recess Holdco LLC is designated as the sole Manager. Persons dealing with the Company are entitled to rely conclusively on the power and authority of the Manager as set forth in this Agreement. Without limiting the powers granted under the Act, the Manager is authorized, directed and empowered, in the name and on behalf of the Company, to take all actions and execute all agreements and other documents (including, without limitation, instruments evidencing indebtedness and instruments of acquisition and conveyance) that the Manager deems necessary, appropriate convenient or advisable to conduct the business of the Company. Action required or permitted to be taken by the Members or the Managers may be taken without a meeting if the action is evidenced by one or more written consents describing the action taken, signed by the Members or the Manager, as applicable, and delivered to the Company for inclusion in the minutes or for filing with the Company records.

(b) Election of Officers; Delegation of Authority. The Manager may, from time to time, designate one or more officers with such titles as may be designated by the Manager to act in the name of the Company with such authority as may be delegated to such officers by the Manager (each such designated person, an “**Officer**”). Any such Officer shall act pursuant to such delegated authority until such Officer is removed by the Manager. Any action taken by an Officer designated by the Manager pursuant to authority delegated to such Officer shall constitute the act of and serve to bind the Company. Persons dealing with the Company are entitled to rely conclusively on the power and authority of any officer set forth in this Agreement and any instrument designating such officer and the authority delegated to him or her.

6. Liability of Member; Indemnification.

(a) Liability of Member. Except as otherwise required in the Act, the debts, obligations, and liabilities of the Company, whether arising in contract, tort or otherwise, shall be solely the debts, obligations and liabilities of the Company, and the Member shall not be obligated personally for any such debt, obligation or liability of the Company solely by reason of being the Member or participating in the management of the Company.

(b) Indemnification. To the fullest extent permitted under the Act, the Member and the Manager (irrespective of the capacity in which it acts) shall be entitled to indemnification and advancement of expenses from the Company for and against any loss, damage, claim or expense (including attorneys’ fees) whatsoever incurred by the Member or the Manager relating to or arising out of any act or omission or alleged acts or omissions (whether or not constituting negligence or gross negligence) performed or omitted by the Member or the Manager on behalf of the Company; provided, however, that any indemnity under this Section 6(b) shall be provided

out of and to the extent of Company assets only, and neither the Member, the Manager nor any other person shall have any personal liability on account thereof.

7. Term. The term of the Company shall be perpetual unless the Company is dissolved and terminated in accordance with Section 11.

8. Initial Capital Contributions. The Member hereby agrees to contribute to the Company such cash, property or services as determined by the Member.

9. Tax Status; Income and Deductions.

(a) Tax Status. As long as the Company has only one member, it is the intention of the Company and the Member that the Company be treated as a disregarded entity for federal and all relevant state tax purposes and neither the Company nor the Member shall take any action or make any election which is inconsistent with such tax treatment. All provisions of this Agreement are to be construed so as to preserve the Company's tax status as a disregarded entity.

(b) Income and Deductions. All items of income, gain, loss, deduction and credit of the Company (including, without limitation, items not subject to federal or state income tax) shall be treated for federal and all relevant state income tax purposes as items of income, gain, loss, deduction and credit of the Member.

10. Distributions. Distributions shall be made to the Member at the times and in the amounts determined by the Member.

11. Dissolution; Liquidation.

(a) The Company shall dissolve, and its affairs shall be wound up upon the first to occur of the following: (i) the written consent of the Member or (ii) any other event or circumstance giving rise to the dissolution of the Company under the Act, unless the Company's existence is continued pursuant to the Act.

(b) Upon dissolution of the Company, the Company shall immediately commence to wind up its affairs and the Member shall promptly liquidate the business of the Company. During the period of the winding up of the affairs of the Company, the rights and obligations of the Member under this Agreement shall continue.

(c) In the event of dissolution, the Company shall conduct only such activities as are necessary to wind up its affairs (including the sale of the assets of the Company in an orderly manner), and the assets of the Company shall be applied as follows: (i) first, to creditors, to the extent otherwise permitted by law, in satisfaction of liabilities of the Company (whether by payment or the making of reasonable provision for payment thereof); and (ii) thereafter, to the Member.

(d) Upon the completion of the winding up of the Company, the Member shall file Articles of Dissolution in accordance with the Act.

12. Miscellaneous.

(a) Amendments. Amendments to this Agreement may be made only with the consent of the Member.

(b) Governing Law. This Agreement shall be governed by the laws of the State of Colorado.

(c) Severability. In the event that any provision of this Agreement shall be declared to be invalid, illegal or unenforceable, such provision shall survive to the extent it is not so declared, and the validity, legality and enforceability of the other provisions hereof shall not in any way be affected or impaired thereby, unless such action would substantially impair the benefits to any party of the remaining provisions of this Agreement.

(d) No Third Party Beneficiaries. This Agreement is for the sole benefit of the Company and the Member, and no other person is intended to be a beneficiary of this Agreement or shall have any rights hereunder. Without limiting the generality of the foregoing, except as otherwise expressly provided in the Act or applicable law, no creditor shall have any rights with respect to any agreement between the Company and the Members with respect to capital contributions or otherwise under this Agreement.



This letter is to advise you that the Douglas County Local Liquor Licensing Authority (Authority) will convene on February 10, 2025, at 1:30 pm for a public hearing due to the results of the required background check received from the Colorado Bureau of Investigation (CBI).

On December 23, 2024, staff received an application to transfer the existing liquor license. The CBI background check results received by Douglas County show relevant criminal history; thus the application is scheduled for a hearing before the Authority.

In accordance with Regulation 44-3-303(I)(C)(III) of the Colorado Liquor Code- "Prior to holding a hearing...the local licensing authority shall notify the applicant of the hearing at least ten days before the hearing and shall post, or may direct the license applicant to post, a notice of the hearing in a conspicuous location on the licensed premises for at least ten consecutive days before the hearing."

The notice must not be less than twenty-two inches wide and twenty-six inches high, composed of letters not less than one inch in height and stating:

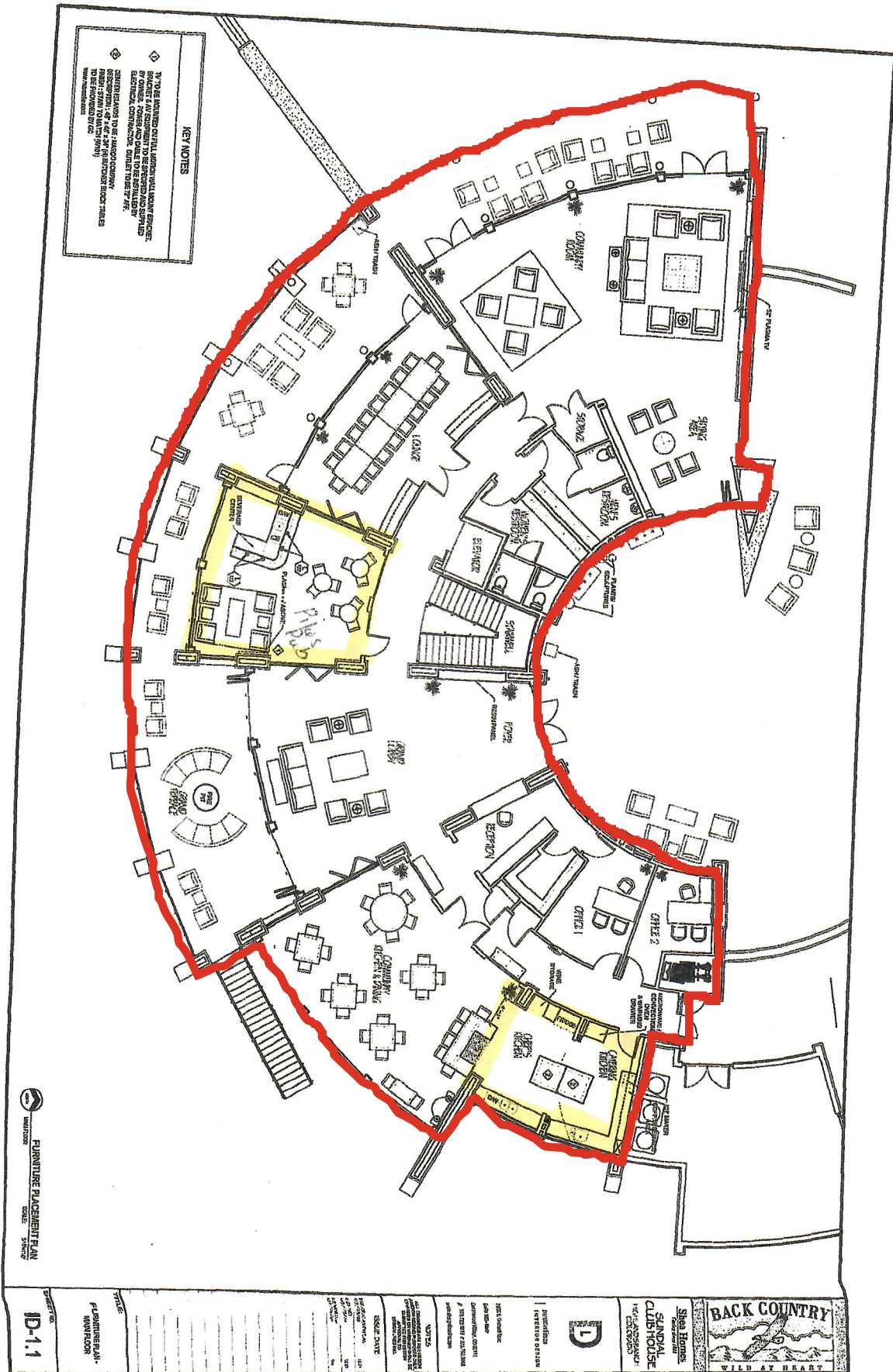

1. **Are the documents which you provided for the liquor license application still accurate and valid?** We recently found out that Lohi Beer Garden, LLC dba Recess had a liquor license violation in 2017 for sale to a minor. The doorman accepted a vertical ID of a police cadet and stamped his arm. The bartender saw the stamp and served the minor police cadet. The employees involved were terminated. We have since instituted a no vertical ID policy.
2. **Is the property leased or owned?** Leased under a Food and Beverage Service Agreement
3. **What is the buildings occupancy limit?** We do not know the occupancy. Can we check the prior licensee's application?
4. **Have you owned or operated a similar establishment with a liquor license in the past?** Yes, our parent company *Recess Hold Co* owns Lohi Beer Garden, LLC dba Recess Beer Garden in downtown Denver since September 2015 and Recess Campus Lounge, Corp dba Campus Lounge in Denver's Wash Park neighborhood, which we acquired in January 2020.
5. **Is this a new or existing business (how long in existence?)** We're transferring ownership of the liquor license of an existing restaurant and will operate our Campus Lounge concept into the space.
6. **How many full and part-time employees do you have?** We will have seven to ten part time employees.
7. **Why type of service do you provide? Is there a menu which can be reviewed?** We are a full-service restaurant. Please see menu attached.
8. **What are the hours of operation for liquor sales?** Thursdays 4pm – 10pm, Fridays 4pm – 11pm, Saturdays 4pm – 10pm.
9. **Are all your employees trained on the liquor code?** All employees will be required to have TIPS or ServSafe certification.

10. **Please list what particular training or program you use?** TIPS or ServSafe
11. **Are there any point of sale systems in place to check identification?** Toast point-of-sale
12. **What do you do if an employee violates the policy and serves a minor?** We have a written zero-tolerance Alcohol Service Policy. If an employee serves a minor, they will be terminated.
13. **How are you going to monitor that your employees are asking for ID? Are you going to have your own compliance check?** Employees will be required to check every ID. We will have our own compliance checks.
14. **Will you have a policy that all individuals purchasing alcohol will be asked for identification and will you post a sign informing customers of this policy?** Our Alcohol Service Policy requires ID checking of anyone who orders alcohol and IDs for each drink ordered.
15. **How is liquor secured during hours of operation and when closed?** All liquor is in a locked cage or locked storage area.
16. **Is there an outside area or patio? If so, how will this area be secured to guarantee that no transfer of alcohol occurs to outside the serving area?** Yes, there is an outside patio area, which is fully visible from the inside service areas through large floor to ceiling windows that surround the patio.
17. **Outside of the formal petition, why do you believe there is a community need and desire in this area for this type of service?** Yes, there is a strong community need and desire for our services. The Back Country Association is a lifestyle community with amenities for its Member Residents and their guests to enjoy. The closing of the business by the previous tenants has left a void for the community. They are eagerly anticipating Campus Lounge Backcountry's reopening of their beloved restaurant and bar area.
18. **Are you confident that you can comply with the liquor code?** Yes, we have operated two other liquor licensed establishments with only one violation in 2017, more than seven years ago.
