SUMMARY: This resolution, through this 5th supplemental budget, amends fiscal year 2025

Adopted Budget by increasing appropriations for new revenues via grants and reimbursements not anticipated in the 2025 Adopted Budget, and appropriated restricted, committed, assigned and unassigned fund balance for new 2025
