A, Parker, CO 80134. Team Lab requires a 10 day lead time from date of purchase order to date of delivery. Typically the lead time is less but just want to cover our bases. Price includes freight to Douglas County PW (address above). County will be responsible for receiving, unloading and storing the 275 gallon totes of Base One for future use. All other duties of transporting the product from the said address above to the jobsite will be the counties (sic) responsibility. The application rate is .005 gallons of Base One per square yard per inch material treated in depth. Example: One 275-gallon tote will treat a road 5,280 feet long by 24 ft. wide by 4 inches deep.
