I. EXECUTIVE SUMMARY

Rock Canyon High School (RCHS) requests a fee waiver in the amount of \$175 for the use of Rueter-Hess Reservoir (RHR) for their outdoor education class fishing expedition on October 23, 2024.

II. BACKGROUND

RCHS Outdoor Education Class would like to use Rueter-Hess Reservoir to enrich their students' lives by teaching them to fish. Each student will experience the outdoors in Colorado and learn the skills needed to fish including the parts of the equipment to the steps of set-up, casting, reeling in, and how to catch and release the fish. This is an ongoing request. RCHS has used Rueter-Hess in both spring and fall semesters and will continue to use the facilities yearly.

III. REQUEST

RCHS requests a fee waiver in the amount of \$175 for the use of the RHR for their outdoor education class for Fall 2024 classes.

IV. STAFF ASSESSMENT

The Board of County Commissioners has the sole authority to waive or reduce all park use fees and may choose to waive or reduce the use fee of \$175 for RCHS.
