As you're driving through Highlands Ranch, take a moment to remember a community hero. Last week, the street signs along Lucent Boulevard were changed to Kendrick Castillo Way. As part of the ongoing mission to memorialize Kendrick – who was killed May 7, 2019, during his senior year of high school, having sacrificed his own life to save fellow students amid a school shooting – the Kendrick Castillo Memorial Oversight Committee requested a street name change, which the Board of Douglas County Commissioners approved earlier this year. Now, your mapping application and the street signs will reflect this important change. The entirety of Lucent Boulevard, about 2 miles from County Line Road to South Broadway, is officially Kendrick Castillo Way. The Committee has also organized the naming of a robotics lab, a memorial in Civic Green Park and a scholarship fund in Kendrick's name.


A total of 30 signs will be changed, including at the major intersections of Kendrick Castillo Way with County Line Road, Plaza Drive, Town Center Drive, Highlands Ranch Parkway and Broadway. The Colorado Department of Transportation will replace signs along C-470 in the near future.

• **HEART Success Story:** HEART received a referral from Castle Rock Police Department of a homeless individual who needed assistance. A HEART Navigator met with the man to assess his needs and barriers before he entered a short-term inpatient program. She worked with the man's provider to help with a safe discharge plan and reached out to the man's sister in Rhode Island who stated that she would provide him with housing and support. Once the client had a discharge date, the Navigator assisted him with a bus ticket to reunite with his sister. Once the man arrived in Rhode Island, his sister provided the Navigator with pictures of them enjoying time together.

## HEART Activity Report - November 2024



Partnerships are expanding local housing solutions for families in need (full story)



On November 20, the GOALS Program celebrated its grand opening with a ribbon-cutting ceremony. The event brought together staff from Douglas and Arapahoe Counties, Family Tree leadership, and community partners to commemorate the launch of this new initiative aimed at supporting families experiencing homelessness.

The partnership – with Arapahoe County and Family Tree – expands the, offering the first-ever countywide resource specifically for families with children experiencing homelessness. Operated by Family Tree, the Generational Opportunities to Achieve Long-term Success (GOALS) program is designed to provide stability and empowerment to the whole family.

The program uses a 2Gen approach to address the unique needs of both parents and children, helping families overcome the challenges of poverty and homelessness. Families are provided with a private room and work closely with supportive staff and case managers to develop long-term goals for stability. Participants in the program stay in safe, temporary shelter for up to nine months while focusing on improving their health and well-being, gaining employment, and building financial stability. The program also emphasizes supporting children's academic success and fostering stronger connections within the community. Ultimately, the program aims to help families transition into stable, long-term housing.

Renovations to the new facility were completed this fall, thanks to contributions from multiple Douglas

County churches. These churches adopted individual rooms, adding a personal and welcoming touch to the spaces where families will live and work toward their goals.

Thanks to a \$1 million grant secured for Douglas County by US Rep. Jason Crow, the GOALS facility in Aurora is expanding its





facilities and creating a home for up to five Douglas County families beginning in December 2024.

Local non-profits receive \$135,000 in Philip. S. Miller Trust grants (<u>full story</u>)



The Board of Douglas County Commissioners has selected 19 non-profit programs to share \$135,000 in grant funds from the County's 2024 portion of the Philip S. Miller Trust. Together, these vital programs cast a wide safety net throughout the County by delivering programs and services such as suicide

prevention, therapy, medical assistance, mental health, emergency financial assistance and support for seniors and school-age children. Recipients of these awards enhance the quality of life for vulnerable and at-risk members of our community, and many provide services not available through other means.

#### Activities November 4 - December 6

- Ridgeglen Way Storm Sewer Replacement: Completed the end of November 2024. Construction started on 9/16/24. This project replaced approximately 343 LF of corrugated metal pipe that has reached its life expectancy and installed two new manholes for access for future maintenance needs.
- Westcreek Road 84-inch Storm Sewer Culvert Replacement: Completed the end of November 2024. Construction started on 10/28/24. The 84" CMP culvert located at 14522 Westcreek Rd was experiencing failures within the top of the pipe storm culvert replaced.



• Lincoln Ave at Stonegate and Keystone Blvd Storm Sewer Culvert Replacement: Anticipated completion by December 15, 2024. Work started on November 4, 2024, on Lincoln Ave between Stonegate Pkwy and Keystone Blvd. During construction, this project will be done in 4-phases, and traffic control shifts will differ with each phase.





#### MS4 and Stormwater Matters

Chatfield Watershed Authority - The Colorado Parks and Wildlife Commission voted to approve the Water Quality User Fee for Chatfield Reservoir on November 14, 2024. This was the final step towards implementing the Water Quality User Fee that was authorized with the passage of Senate Bill 23-267. Starting Jan 1, 2025, Colorado Parks and Wildlife will charge an additional two dollars for the purchase of daily park passes at Chatfield Reservoir. The Authority is required to use the revenue provided by the fee for projects that are beneficial to water quality, including using up to twenty-five percent for water quality projects within the state park. OC CLEAR - The Douglas County Cooperative for Local Environmental Awareness and Responsibility (CLEAR) has completed a project focused on revamping the public education ads, which now run full-page ads in color in Colorado Community Media Newspapers (See ad below). These ads are also used for outreach by DC CLEAR on several social media platforms which were launched mid-year 2024. Projects planned for 2025 include website content revisions, increasing the effectiveness of targeted outreach, and assisting member entities to meet their MS4 Permit requirements.



• We are pleased to announce that **Tim Pendleton has been selected for Deputy Building Official**, effective



November 4, 2024. Tim brings over 25 years of experience in the construction industry, including the last 12 years as Chief Building Official for the Town of Collierville, Tennessee. #### **Operations and Pavement Management**

 November Snowstorm Stats: Total lane miles plowed throughout the County was 33,727. Total material usage: 460 yards of salt/sand, 2,576 salt, and 27,163 gallons of MgCl, and total cost of this storm was \$554,680.24.

- Invasive Weeds Management Program: 1,508 swath miles mowed YTD; 334 acres sprayed YTD
- Survey: The survey has wrapped up on East Parker Road and Miller Road. Traffic has increased with the
  Ave Maria Catholic School drop-off and pick-up of students. This work will also include the reclamation of
  numerous County G.I.S. control points within a several-mile radius, which have not been confirmed in over
  ten years.

 Staff assisted the CIP team with locating Rights-of-ways in Charter Oaks Subdivision located in Castle Pines. The research included Section Corner Monument Records as well as Plats/Amended Plats. Finding existing property delineations and property corners can be tricky, especially on older filing like these.

# Traffic

• Traffic Signal Annual Structure Testing - Annual Non-Destructive Signal Structure testing was completed



this past October. Non-destructive testing involves looking at signal poles to inspect for cracks at weld seams or elsewhere, loss in cross-section due to corrosion as well as other potential issues that might impact structural soundness. Typical tests include magnetic particle imaging and ultrasonic sound testing processes. Douglas County traffic signal poles are typically

inspected on a 4-year recurring timeframe unless issues are found that require more frequent inspections. This program ensures that Douglas County staff are aware of the physical condition of signal equipment as it ages over time.

 Traffic Signal Annual Conflict Monitor Testing - Annual Conflict Monitor Testing was completed in December. Conflict monitor testing is required to ensure this vital piece of

December. Conflict monitor testing is required to ensure this vital piece of equipment is functioning correctly at the intersection. Conflict monitors measure the electrical outputs of all traffic signal circuits to ensure that conflicting directions are never displayed green balls simultaneously. County staff follow FHWA and CDOT guidance to ensure our annual testing program is in compliance with industry guidelines and that this equipment is operating correctly to ensure the driving public's safety.



• Traffic Signal Pole Paint Program - The annual Traffic Signal Pole Paint Program is intended to address coatings that are compromised or otherwise in need of complete repainting to maintain an effective barrier against the elements and other substances that corrode and degrade the structural performance of this infrastructure. In 2024, 12 locations were completed.

## **Human Services**

• Family Support – Douglas County has joined 13 other counties across Colorado in activating an enrollment



freeze for the Colorado Child Care Assistance Program (CCCAP). This decision stems from a sharp decline in anticipated funding coupled with the impact of costly new federal regulations. Currently, Douglas County supports 435 families, providing childcare subsidies for 552 children. These families will continue to receive assistance under the program. However, no new families will be able to receive low-income childcare assistance at this time.

Eligibility - The Douglas County Department of Human Services continues to see the highest volume, to



date, of individuals accessing many of our safety net programs, such as the Supplemental Nutrition Assistance Program (SNAP). The number of Douglas County residents receiving assistance from the SNAP program is at an all-time high of 10,780. The number of individuals accessing health insurance through

Medicaid is climbing and is currently at 26,773. The team also receives over 600 applications for SNAP, over 660 applications for Medicaid, and over 250 applications for cash assistance programs on a monthly basis. Additionally, the Douglas County team conducts over 1,330 monthly reassessments of eligibility across all of the programs that we administer. The number of individuals seeking out assistance highlights how vital

the role that this team serves is to the most vulnerable members of our community, as well as giving a glimpse into the number of individuals and families in need.

#### The Department of Human Services is excited to announce two leadership promotions:

- Ruby Richards has risen to the role of Director of Human Services. With over ten years of dedicated service in Douglas County and over 30 years in Child Welfare, Ruby's exceptional leadership as Deputy Director and Child Welfare Administrator has demonstrated her unwavering commitment to the department's mission. Her understanding of the department's operations and her passion for service make her the perfect choice to lead the department into the future.
- Nicole Adams has been appointed as the Assistant Director of the Protective Services Division. With over 14 years of valuable experience with Douglas County, Nicole has excelled in her previous roles as Intake Supervisor and Intake Manager. Her extensive expertise in child and adult protection, combined with her natural leadership abilities, positions her as a respected figure not only within our department but also in the broader community.

#### • A/D Works! - Successes/Highlights

- o In November, the U.S. Department of Labor (DOL) recognized A/D Works! as Apprenticeship Navigators for its work to strengthen, expand, and diversify Registered Apprenticeship over the past two years!
- DCSD Legacy Campus hosted the Q4 Aerospace Sector Partnership meeting. There were approximately 50 members from business and education who attended and toured the aviation and robotics areas. They are all excited to engage with students in the future. In addition, A/D Works! will be working with them to host a series of job fairs targeted towards their pathways starting in January.
- Jamie Fisher, Business Services Manager, spoke at the Space Roundup reception dinner on December 3<sup>rd</sup> and during the conference on December 4<sup>th</sup> to discuss the success of the teacher externs this past year. This topic was requested by Joe Rice with Lockheed Martin Space.



## • Events/Workshops

- On Wednesday, November 20th, Andrea Barnum, Workforce Programs Manager, presented to the Douglas County Community of Care Network about "Benefit Cliffs and Financial Planning with Job Seekers", showcasing A/D Works! financial literacy workshops and the Career Ladder Identifier and Financial Forecaster (CLIFF) Tools created by the Federal Reserve. These tools help job seekers receiving public benefits understand the short-term and long-term impacts of a new job or career pathway. They also help benefit recipients understand and plan for the cliff effect.
- A/D Works! hosted the Q4 Programs Job Fair on November 20th.
  - 25 employers attended
  - 289 jobseekers logged in and attended the job fair
  - 120 of the 289 identified as program participants for a 42% attendance rate for program participants
- A/D Works! staff attended the Family Tree and Douglas County Open House on November 20th to celebrate the opening of the new residential space at the GOALS campus for Douglas County families experiencing homelessness. A/D Works! is onsite to provide workforce services and to help connect those individuals to opportunities that will help lead to self-sufficiency.

 On December 17th, the new Money Matters workshop will be offered at the A/D Works! resource center at ACC Sturm. This workshop was developed to help public assistance recipients understand their net financial resources and help them plan for benefit cliffs.

# **Office of Emergency Management**

• The Emergency Services Unit concluded their 168 Exclusive Use Helicopter Contract on November 15<sup>th</sup>. Summary statistics from the year's accomplishments are displayed below:

- Staff participated in an Active Threat Tabletop Exercise with Douglas County Libraries executive staff. Partners completed the exercise with better understanding of roles, responsibilities and key coordination points between various members of staff and external agencies.
- Staff met with representatives from Xcel Energy to continue planning and coordination efforts related to Public Safety Power Shutoffs. OEM staff continues working on Critical Action Guides and Long-Term Power Outage Annexes designed to better prepare the county for these events.
- Staff attended the International Association of Emergency Managers conference, hosted by the Broadmoor in Colorado Springs.

# **Open Space and Natural Resources**

• Dawson Butte Open Space and Trail Current Trail Closure - If you visit Dawson Butte Ranch Open Space for



activities like hiking, horseback riding or cross-country skiing, please plan ahead for a trail closure at the southwest end of the open space through the month of December. Beginning, Monday, Dec. 2 of an approximate half-mile portion of the trail will be closed 24/7 for up to 4 weeks for forest management work. All other portions of the trail system will remain open.

• **Mooo-ving Snow** - All hands were on deck for the first significant snow event of the season which occurred November 6th through the 8th. Approximately 15 hours of Open Space staff time was utilized in snow removal efforts on the guided side of Sandstone Ranch Open Space alone. The snow removal was critical

for the cattle owned by Welch Brothers Cattle, LLC. The nearly 30" of snowfall in that timeframe, along with even deeper drifts, would have prevented the cattle from accessing food and water. These cattle are part of a grazing program that results in a higher level of rangeland health for the soil and improves pasture fertility that occurs from properly managed cattle grazing program. The cattle also help to preserve the character of Sandstone Ranch as a rural, historic working cattle ranch.


