Dear Mr. Jakubowski,

We respectfully request that the BOCC grant the Applicant a continuance of the BOCC's deliberation regarding the Pine Canyon PD Rezoning and Water Appeal (ZR202-010 and MI2020-009). Our request is for an additional two months extension from the October 22, 2024 date to the planned December 17th Land Use Meeting.

Under County Staff oversight, the Applicant and staff of the Town of Castle Rock have held substantive meetings addressing the Town's opposition to our pending applications. Town Staff has expressed a willingness to consider and present to Town Council a "pre-annexation" agreement. The Applicant's counsel is drafting such a proposal.

Additional time is needed to develop and present the necessary legal documents. Under the circumstances, the Applicant believes an additional continuance is warranted.
