EXHIBIT A SCOPE OF SERVICES AGREEMENT 2025-03

THIS SCOPE OF SERVICES AGREEMENT ("SOSA") is made and entered into this	day
of, 2025, by and between the BOARD OF COUNTY COMMISSIONERS OF TI	HE
COUNTY OF DOUGLAS, STATE OF COLORADO (the "County"), and HARRIS CORRECTIO	NS
SOLUTIONS INC., authorized to do business in Colorado (the "Consultant"). The County and the Consult	ant
are collectively referred to herein as the "Parties".	

RECITALS

WHEREAS, the Parties entered into an active Master Services Agreement dated November 13, 2023, (the "MSA") for the Consultant to perform services for the County governed and executed through Scope of Services Agreements (SOSA); and

WHEREAS, the County would like the Consultant to provide product feature development and custom software changes to the Offender360 applications. These changes are based on enhancements requested and defined between Douglas County and Harris Corrections; and

WHEREAS, the County has budgeted and appropriated the necessary funds to satisfy the financial obligations set forth in this SOSA.

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the Parties agree as follows:

- 1. MASTER SERVICES AGREEMENT: This SOSA is subject and subordinate to the terms and conditions specified in the MSA, executed between the Parties.
- 2. SCOPE OF WORK: All services described in <u>Exhibit 1</u>, attached hereto and incorporated herein, shall be performed by the Consultant.
- 3. MAXIMUM CONTRACT LIABILITY: Any other provisions of this SOSA notwithstanding, in no event shall the County be liable for payment under this for any amount in excess of **One Hundred thousand dollars and zero cents** (\$100,000.00). The County is not under obligation to make any future apportionment or allocation to this SOSA. Any potential expenditure for this SOSA outside the current fiscal year is subject to future annual appropriation of funds for any such proposed expenditure.
- 4. TERM: It is mutually agreed by the Parties that the term of this SOSA shall commence as of 12:01 a.m. on December 1, 2025, and terminate at 11:59 p.m. on December 31, 2026. This SOSA and/or any extension of its original term shall be contingent upon annual funding being appropriated, budgeted and otherwise made available for such purposes and subject to the County's satisfaction with all products and services received during the preceding term.
- **5. COUNTY EXECUTION OF AGREEMENT**: This SOSA is expressly subject to and shall not be or become effective or binding on the County, until execution by all signatories of the County.

Douglas County Enhancements Project

1. Scope of Services

Harris Corrections ("HCOR") shall collaborate with the Authorized Representative of Douglas County ("County"), or an individual designated by the Authorized Representative, to perform the professional services described herein. HCOR's responsibilities are limited to the specific development and testing services defined in this Scope of Work.

2. Background

During the User Acceptance Testing (UAT), HyperCare, and Post Go-Live phases of the Offender360 implementation, which went live on June 23, 2025, Douglas County representatives identified various enhancements and backlog items. These requests have been tracked alongside bug reports for the past twelve (12) months in HCOR's Azure DevOps instance.

HCOR has since addressed nearly all critical and high-priority defects and a significant number of mediumand low-priority defects. Remaining defects will be addressed pursuant to the HCOR support agreement. Joint efforts between the County and HCOR have been undertaken to validate, prioritize, and estimate the remaining enhancement requests.

This SOW defines the specific services HCOR will provide to complete the current set of enhancements and as mutually agreed upon in writing, additional enhancements that may be identified during the course of this project at the cost provided by HCOR. SOSA 2025-003 covers the cost of CR-011 in the amount of sixty thousand three hundred ninety dollars and zero cents (\$60,390.00) and any additional enhancements agreed to in writing by the County and HCOR, not to exceed one hundred thousand dollars and zero cents (\$100,000.00)

3. Deliverables

- HCOR shall provide development and testing services for the 60 enhancements listed in Change Request CR-011 (Exhibit 2), as documented in HCOR's Azure DevOps system, which shall serve as the initial scope description for the CR. HCOR development/delivery specification detailing each deliverable will be generated by HCOR and provided to Douglas County for acceptance prior to the commencement of development.
- Any new or modified enhancements requested by the County will require mutual written agreement, including documented requirements, estimates, and timeline confirmation, prior to commencement.
- The County and HCOR will jointly determine the order and batching of work based on County priorities and HCOR resource availability. A minimum of two releases will be delivered in 2026.
- The overall work for CR-011 is expected to be completed no later than September 30, 2026, provided that all necessary information, access, and approvals are provided by the County.

HCOR's obligation is limited to performing work as specified herein using commercially reasonable efforts. HCOR does not guarantee that all requested enhancements beyond those approved will be feasible or implemented.

4. Compensation

Each enhancement included in this SOW has been assigned a fixed, not-to-exceed price based on mutually agreed estimates.

• Any additional enhancement requests shall be separately estimated and require the County's written approval, via Change Request document, before work begins.

• HCOR will invoice the County 50% of the cost upon execution of this agreement and the remaining 50% upon delivery of the items included in a given release.

HCOR's total liability for any claim under this SOW shall not exceed the total amount paid and due for services performed under this SOW.

5. Not-to-Exceed Commitment

HCOR's total compensation for all services performed under this SOW shall not exceed the amount specified in the CR, without prior written approval by both parties.

HCOR's estimates and delivery timelines are based on the information currently available. Any material change in scope, requirements, or County dependencies may impact delivery schedules and costs.

No additional work shall be performed unless both parties have executed a written amendment (Change Request) specifying the change.

6. Changes and Termination

Any change to the scope, schedule, or cost of this SOW must be documented in writing and approved by both parties before the work proceeds.

If the parties are unable to reach agreement on a requested change, the County may elect to terminate further work under this SOW. In such an event:

- The County shall pay HCOR for all work performed to the date of termination; and
- HCOR shall have no further obligation or liability for unperformed or cancelled work.

HCOR shall not be liable for delays, indirect damages, loss of profits, or consequential damages arising from or related to this SOW.

7. Entire Understanding

This SOW represents the full and complete understanding between the parties regarding the subject matter herein and shall be governed by the terms and conditions of the SOSA 2026-001 Master Agreement.
