### LEASE TERMINATION AGREEMENT

This Lease Termination Agreement ("Agreement") is made and entered into as of this 6th day of September 2025, by and between BVI, Inc. ("Landlord") and Douglas County Colorado ("Tenant").

#### RECITALS

This Agreement is made and entered into in contemplation of the following facts, intentions and understandings of the parties:

- A. Landlord and Tenant entered into a Lease Agreement dated April 11, 2017 (the "Lease"), for premises located at 410 Wilcox, Suite 101, Castle Rock, CO more particularly described in the Lease ("Premises").
- B. The Parties entered into a First Amendment to the Lease on February 22, 2022, which added Suite 103 to the definition of the Lease Premises.
  - C. Tenant has requested an early termination of the Lease with respect to Suite 103.
- D. Landlord and Tenant now desire to terminate the Lease with respect to Suite 103, subject to the terms and conditions herein stated.

### **AGREEMENT**

NOW, THEREFORE, on the basis of the foregoing facts, understandings and intentions of the parties, and for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties hereto agree as follows:

- 1. <u>Termination</u>. The First Amendment as it applies to the addition of Suite 103 of the Premises shall terminate effective as of August 29, 2025("Lease Termination Date").
- 2. <u>Prepaid Rent and CAM</u>. Landlord will refund to Tenant the amount of prepaid Rent and CAM for September through December 2025. Accordingly, Landlord agrees to refund prepaid rent in the amount of fourteen thousand nine hundred thirty-one dollars and fifty-eight cents (\$14,931.58) to Douglas County.
- 3. <u>Utilities</u>. Tenant shall continue to pay all charges for utility services with respect to Suite 101 up to and including the Lease Termination Date of September 30, 2027.
- 4. <u>Tenant Representations</u>. Tenant represents and warrants that: (a) it has not subleased Suite 103 of the Premises; (b) Tenant has no knowledge of any potential claims arising out of Tenant's occupancy of Suite 103 of the Premises; and (c) no work has been done to Suite 103 of the Premises which has not been fully paid for .

- 5. <u>Release.</u> Upon acceptance of the Premises by Landlord in satisfaction of the conditions described herein, Landlord shall be deemed to have released Tenant with respect to Suite 103, and Tenant shall be deemed to have released Landlord from all obligations under the First Amendment to the Lease with respect to Suite 103 except as provided herein.
- 6. <u>Delivery of Possession</u>. As of September 2, 2025, Tenant has vacated Suite 103 of the Premises and delivered possession thereof to Landlord, broom clean and free of all of Tenant's furniture, fixtures and equipment.
- 7. <u>Obligations Surviving Termination of Lease</u>. The termination of the Lease with respect to Suite 103 and the surrender of Suite 103 of the Premises shall not release or discharge Tenant's obligations set forth in this Agreement with respect to Suite 101.

## 8. Miscellaneous

- a. <u>Successors</u>. This Agreement shall be binding upon and shall inure to the benefit of the successors and assigns of each of the parties hereto.
   <u>Entire Agreement</u>. This Agreement contains the entire understanding between the parties hereto with respect to the subject matter hereof and supersedes any and all prior or other contemporaneous understandings, correspondence, negotiations or agreements between the parties respecting the subject matter hereof.
- b. <u>Applicable Law.</u> The terms and provisions of this Agreement shall be governed pursuant to the laws of the State of Colorado and the exclusive venue for any legal proceedings to enforce this Agreement shall be in the County of Douglas, State of Colorado.
