

Seventh Amendment to Master Services and Purchasing Agreement

This Seventh Amendment (**Amendment**) is between Axon Enterprise, Inc. (**Axon**), and Douglas County, Colorado on behalf of Douglas County Sheriff's Office (**Agency**). This Amendment is effective as of the last signature date on this Amendment.

On June 28, 2016, the parties entered into a Master Services and Purchasing (**Agreement**).

On April 5, 2017, TASER International, Inc. changed its corporate name to Axon Enterprise, Inc. (**Axon**).

On March 26, 2019, the parties approved the First Amendment to the Agreement to extend the original agreement, add additional hardware, and upgrade the existing fleet camera systems.

On October 24, 2019, the parties approved the Second Amendment to the Agreement to add additional hardware to the Agreement.

On June 22, 2020, the parties approved the Third Amendment to the Agreement to add additional hardware to the Agreement.

On August 13, 2020, the parties approved the Fourth Amendment to the Agreement to reflect Agency's upgrade to Axon's Officer Safety Plan 7 (OSP 7).

On August 10, 2022, the parties approved the Fifth Amendment to the Agreement to reflect Agency's upgrade to Axon's Officer Safety Plan 7 Plus (OSP 7+) with Auto-Transcribe and adding Fleet 3 with Automatic License Plate Reader (ALPR) functionality.

On March 6, 2023, the parties approved the Sixth Amendment to the Agreement to add additional Officer Safety Plans for newly approved FTEs and Vehicle Camera Systems.

The Parties now wish to incorporate certain changes into the Agreement to include additional Axon Officer Safety Plans (OSP 10) with the Auto-Transcribe feature, additional Fleet 3 Camera Systems with Automatic License Plate Reader (ALPR) capabilities, Axon Fleet licensing for real time location, alerts and livestream, new Taser 10 plans, and additional pro and basic licenses.

The Parties therefore agree as follows:

1. To incorporate Attachment C: Quote #Q-664557-45768BM.
2. To incorporate: (i) TASER Device Appendix; and (ii) Axon Investigate Appendix.
3. Section 16 – Maximum Contract Liability is replaced with the following: **MAXIMUM CONTRACT LIABILITY:** Any other provisions of this Agreement notwithstanding, in no event shall the County be liable for payment under this Agreement for any amount in excess of twelve million, eight hundred twenty-nine thousand, six hundred sixty-seven dollars and seventeen cents (\$12,829,667.17) for the eight- year contract period ending September 14, 2030, subject to annual appropriations. The County is not under obligation to make any future apportionment or allocation to this agreement.

4. The following is added to the Evidence.com Terms of Use Appendix:

“Provided Data” means de-identified, de-personalized, data derived from Customer's TASER energy weapon deployment reports, related TASER energy weapon logs, body-worn camera footage, and incident reports.

“Transformed Data” means the Provided Data used for the purpose of quantitative evaluation of the performance and effectiveness of TASER energy weapons in the field across a variety of circumstances.

TASER Data Science Program. Axon will provide a quantitative evaluation on the performance and effectiveness of TASER energy weapons in the field across a variety of circumstances.

If Customer purchases the TASER Data Science Program, Customer grants Axon, its affiliates, and assignees an irrevocable, perpetual, fully paid, royalty-free, and worldwide right and license to use Provided Data solely for the purposes of this Agreement and to create Transformed Data. Customer shall own all rights and title to Provided Data. Axon shall own all rights and title to Transformed Data and any derivatives of Transformed Data.

Axon grants to Customer an irrevocable, perpetual, fully paid, royalty-free, license to use to TASER Data Science report provided to Customer for its own internal purposes. **The Data Science report is provided “as is” and without any warranty of any kind.**


In the event Customer seeks Axon's deletion of Provided Data, it may submit a request to privacy@axon.com. Where reasonably capable of doing so, Axon will implement the request but at a minimum will not continue to collect Provided Data from Customer.

5. All other terms and conditions of this Agreement shall remain unchanged and in full force and effect. Each representative identified below declares that the representative is authorized to execute this Amendment as of the date of signature.
