**A RESOLUTION APPROVING THE TEMPORARY ROAD CLOSURES OF COUNTY  
LINE ROAD BETWEEN UNIVERSITY BOULEVARD AND BROADWAY**

**WHEREAS**, Douglas County PW Engineering staff is requesting four temporary road closures for associated with the Pine Drive and Pine Lane Improvements Project, Douglas County Project Numbers CI 2020-019 and CI 2020-020; and

**WHEREAS**, the first, second, and third closures are needed for installation of a new 96-inch culvert that passes under the intersection of Pine Lane and Ponderosa Drive, as well as associated roadway improvements; and

**WHEREAS**, Pine Lane and Ponderosa Drive are County-maintained roadways; and

**WHEREAS**, the Board of County Commissioners (the “Board”) has the authority to temporarily prohibit the operation of vehicles upon roads within its jurisdiction, pursuant to sections 42-4-106(1) and (6), C.R.S.; and

**WHEREAS**, the first closure shall not exceed 18 days (up to 6 days at a time), the second closure shall not exceed 85 days, and the third closure shall not exceed 25 days (closures up to 2 days at a time) and will all take place July 15, 2026 and July 29, 2027, depending on the project phasing and contractor’s approved construction schedule; and

**WHEREAS**, the first closure will be on the south side of the Pine Drive and Ponderosa Drive intersection and extend approximately 1000 feet to the south on Pine Drive, the second closure will be on Ponderosa Drive on the west side of the intersection of Ponderosa Drive and Pine Drive, and will extend 1000 feet to the west, and the third closure will be on Ponderosa Drive on the east side of the intersection of Ponderosa Drive and Pine Lane, and will extend 500 feet to the east; and

**WHEREAS**, the fourth closure is needed for required storm infrastructure improvements, new roadway construction and ancillary roadway improvements on Pine Lane; and

**WHEREAS**, the fourth closure shall not exceed 85 days and will take place July 15, 2026 and July 29, 2027, depending on the project phasing and contractor's approved construction schedule; and

**WHEREAS**, the fourth closure starts at the western side of the Pine Lane and Pine Drive intersection and extends west on Pine Lane to Crown Crest Boulevard; and

**WHEREAS**, during all closures, access to all residents, churches, and businesses will remain open throughout the duration of these closures; and

**WHEREAS**, Douglas County PW Engineering staff will review and approve detour and signage plans for the closures of Pine; now, therefore,

**BE IT RESOLVED**, by the **BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF DOUGLAS, STATE OF COLORADO**, hereby authorizes the approval of four temporary road closures for associated with the Pine Drive and Pine Lane Improvements Project, Douglas County Project Numbers CI 2020-019 and CI 2020-020.

**BE IT FURTHER RESOLVED** that the first closure shall not exceed 18 days (up to 6 days at a time), the second closure shall not exceed 85 days, and the third closure shall not exceed 25 days (closures up to 2 days at a time) and will take place between July 15, 2026 and July 29, 2027 on Pine Drive and Ponderosa Drive.

**BE IT FURTHER RESOLVED** that the second closure will take place between July 15, 2026 and July 29, 2027 and is for required storm infrastructure improvements, new roadway construction and ancillary roadway improvements on Pine Lane between Pine Drive and Crown Crest Boulevard.

**BE IT FURTHER RESOLVED** that a signed detour route with approved warning signs and barricades shall be erected at designated locations, prior to the temporary closure authorized herein.

**BE IT FURTHER RESOLVED** that such warning signs and barricades shall be removed and such road shall be reopened upon expiration of the temporary closure approved herein, or at such earlier time as determined by PW Engineering staff.
