SUBJ: Skaggs Uniform Purchase Waiver

I am writing to request a waiver of the county purchasing guidelines to allow for the purchase of Blauer uniforms (pants and shirts) from Skaggs Uniforms. The Douglas County Sheriff's Office (DCSO) has predominantly sourced uniforms from Galls, which holds a Sourcewell number. After reviewing this quote, it is clear that Skaggs Uniforms offers a significantly lower price for these items and includes sewing on patches and name tags in the price.

While Skaggs does not participate in formal government procurement programs, their pricing is very competitive compared to other government purchasing options available to us. Understanding the constraints of our current budget, we are seeking to operate outside the standard purchasing process to maximize our purchasing power.

This request is made in the spirit of fiscal responsibility and to ensure that the DCSO can continue to provide the necessary uniforms for our personnel without exceeding budgetary limitations.

We therefore seek approval to initiate a purchase request for uniforms from Skaggs

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO County of Douglas, CO (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ### **Getting paper copies**
