WHEREAS, Cardel Vivant, LLC is in default in the performance of its obligations under the SIA; and

WHEREAS, Cardel Vivant, LLC was provided with a minimum of fourteen days written notice of Douglas County's intention to draw on said Letter of Credit: and

WHEREAS, Cardel Vivant, LLC was provided with timely notice of the hearing on this matter; and

WHEREAS, the Board of County Commissioners has concluded that in order to maintain its security for the performance of the obligations of Cardel Vivant, LLC, under the terms of the SIA, it must draw on said Letter of Credit No. 109337-307, in the amount of \$290,388.39 now, therefore,

BE IT RESOLVED by the Board of County Commissioners of the County of Douglas, State of Colorado, that the Chair or Vice Chair of the Board of County Commissioners is authorized and directed to draw on said Letter of Credit No. 109337-307, issued by Flagstar Bank, N.A., in the amount of \$290,388.39, and to execute any statement, draft, or other documents necessary to accomplish said draw on or before December 31, 2025; now, therefore,
