WHEREAS, the Parties entered into a certain Public Agreement for Services dated September 10, 2019 (the "Agreement"); and

WHEREAS, affordable housing has become an increasingly acute issue throughout Colorado, particularly for individuals with developmental disabilities and their families residing in Douglas County; and

WHEREAS, the County and DP desire to cooperate to address this issue by temporarily increasing the funding specifically available for the development of affordable housing for individuals with developmental disabilities, to be administered through a competitive Request for Proposals (RFP) process; and

WHEREAS, the County has budgeted and appropriated the necessary funds to satisfy the financial obligations set forth herein.

NOW, THEREFORE, the parties hereto mutually agree as follows:

1. Exhibit B of the Agreement is hereby amended with the following additional language:

"Affordable Housing RFP Set-Aside (2026–2028):

Beginning in fiscal year 2026 and continuing through fiscal year 2028, the County shall withhold \$850,000 annually from the Net Disbursement to Developmental Pathways, Inc. The County shall withhold these funds in equal monthly amounts of \$141,667 from January through May and \$141,665 in June of each applicable year. This schedule aligns with the period during which approximately 95% of property tax revenues are collected. These funds shall be reserved specifically to support a competitive Request for Proposals (RFP) process for the development of affordable housing for individuals with developmental disabilities residing in Douglas County. The County shall administer the RFP process and retain discretion over the use and disbursement of these funds. Any unspent funds from this set-aside at the end of each fiscal year shall roll forward and remain dedicated to this purpose."

2. The remainder of the Agreement shall remain in full force and effect.
