**DESCRIPTION:** The AXON Enterprises Master Services and Purchasing Agreement is Being Restructured to Include the AXON Records Management System (RMS) and DraftOne Report Writing. This Restructuring will also Introduce Guaranteed Pricing that Remains in Effect Until February 28, 2035 in an Amount of \$30,526.965.56.

**SUMMARY:** The Sheriff's Office has been in partnership with Tyler since 2009, with several key systems integrated into the current Tyler service agreement, including RMS, the Jail Management System (JMS), and Enterprise CAD (Dispatch). While Tyler has historically been a reliable partner, we have observed a significant decline in customer service in recent years, with IT tickets taking several months to receive responses and resolutions. Additionally, there has been a lack of innovation to assist Tyler customers in transitioning to the Artificial Intelligence era.

Through months of research and conversations with various vendors, AXON Enterprises has developed an RMS that not only incorporates AI technology but also integrates seamlessly with several existing systems that the Sheriff's Office is currently under contract with AXON Enterprises, such as Body Worn Cameras (BWC), Vehicle Cameras, and Tasers. AXON's RMS is fully cloud-based, eliminating the need for ongoing maintenance of on-premise data systems. AXON's report writing tool, DraftOne, has the potential to save a deputy up to 70% of report writing time, through a Criminal Justice Information Services (CJIS) compliant platform.

Transitioning to AXON RMS is anticipated to result in budget savings of approximately \$800,000 to \$1,000,000 by eliminating other applications currently in use. These saved funds would then be allocated towards the 2028 contracted increase of \$1,630,192 with the remaining funding to be requested through the annual 2028 budget process for approval and adoption. The contract restructuring would be handled via Sourcewell allowing the Sheriff's Office to forego the RFP process.
