- **In honor of a local hero — Kendrick Castillo Memorial unveiled on Friday, Nov. 14** - When the call went



out in 2024 asking the community to help fund a memorial for Kendrick Castillo, the response was immediate — and overwhelming. Within just a few days, the \$30,000 goal was fully funded, with donations continuing to pour in from people eager to help honor a young man whose bravery continues to inspire us all. The Kendrick Castillo Memorial Monument was officially unveiled at 10 a.m. on Friday, Nov. 14, at Civic Green Park in Highlands Ranch. Together, we celebrate not only the lasting tribute to a young man whose compassion continues to inspire, but also the unity of a community that came together to make it possible. - **Recognition for our nation's heroes in 2025: Operation Green Light** - Did you know that among your



neighbors in Douglas County, about 27,000 (7.7% of the population) are Veterans? To honor the service and sacrifice of these men and women in advance of Veterans Day, Douglas County took part in Operation Green Light for Veterans, Nov. 4 – Nov. 11.

Led by the [National Association of Counties \(NACo\)](#), Operation Green Light is an opportunity for communities to recognize the sacrifices made by our Veterans and their families by illuminating public buildings in green for one week. The initiative also raises awareness around the unique challenges faced by many Veterans and the resources available at the county, state and federal levels to assist Veterans and their families.

As part of Operation Green Light, Douglas County illuminated the Philip S Miller Building, Wilcox Street Building, Justice Center and the County facility on Lansing Point in Meridian. Also in honor of the men and women of the armed forces, the Board of Douglas County Commissioners, Douglas County Veterans Service Office and the Douglas County Veterans Monument Foundation held a Veterans Day ceremony to honor our American heroes on November 8 at the Veterans Monument Plaza, 301 Wilcox St. in Castle Rock.

Office of Emergency Management (OEM):

- **Emergency Management Officials proactively fight fire with fire in Spruce Meadows Open Space** - If you live near Larkspur or hike at Spruce Meadows Open Space, you may have seen smoke in the sky on November 12. It was part of a carefully planned prescribed fire designed to make your community safer and the land healthier for generations to come. Weather and air-quality conditions allowed Douglas County to conduct a prescribed fire on approximately 382 acres in the Spruce Meadows – Mathews Pasture area, located about five miles south of Larkspur. This prescribed burn went according to plan and will effectively:
 - Reduce wildfire risk to nearby communities like Larkspur, Perry Park, and Palmer Park



- Improve wildlife habitat, soil health, and water quality
- Suppress invasive species such as tall oatgrass, knapweed, bull thistle, and yellow toadflax
- Provide critical training for local fire and emergency response teams in a non-emergent, collaborative environment

- The Douglas County Emergency Operations Center (EOC) is back online, following significant technology upgrades to improve capabilities and maximize systems for coordination and situational awareness.
- Staff provided a second session of the Douglas County Citizen Disaster Preparedness Workshop at Parker PD, in collaboration with Parker OEM.
- Staff continue assisting the City of Lone Tree with evacuation planning.

Human Services

- **Important update for Colorado WIC families** - Colorado WIC clinics will remain open, and food benefits will continue to be available in November 2025. The State of Colorado created a stopgap in case the federal government shutdown continues.

- Keep using your eWIC card to buy WIC-approved foods as usual.
- Attend your WIC appointments as scheduled.
- November benefits became available starting Nov. 1.



Note: WIC and SNAP (food assistance) are separate programs, though many families participate in both. Please visit [the Colorado Department of Human Services webpage](#) for updates on SNAP funding and benefit availability.

- **You don't have to struggle with heating costs. Help is available for the 2025-26 season.** Do you need a



helping hand with the cost of heating? Douglas County residents who need help as cold weather approaches may apply for energy assistance through the State of Colorado's Low-Income Energy Assistance Program (LEAP). The program is seasonal, and help is available from Nov. 1, 2025, through April 30, 2026. While the program is not intended to pay the entire cost of home heating, if you are eligible, it aims to help alleviate some of the burdens that come with Colorado's colder months. - **Youth voices lead Douglas County Opioid Council campaign to celebrate choices among teens** - Ninety-four percent of Douglas County teens have never misused prescription pain medicine. As a community, it is our job to build on this success by celebrating the healthy choices our youth are making and educating them about the dangers of opioid use. On Monday, Nov. 10, the Douglas County Opioid Council launched a new public awareness campaign designed to reinforce the positive social norms among teens who choose to live life substance-free. Projects or Grants

- **Aurora Regional Navigation Campus** – On November 6, Community Services staff attended the ribbon-cutting and grand opening ceremony for the Aurora Regional Navigation Campus.

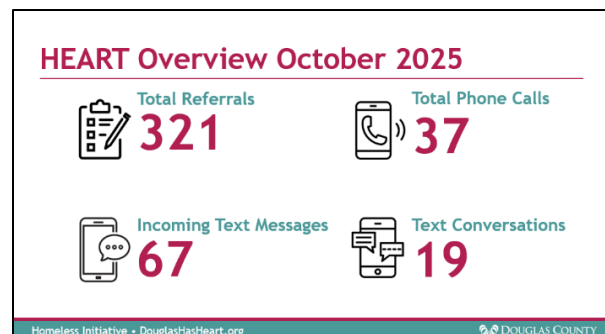
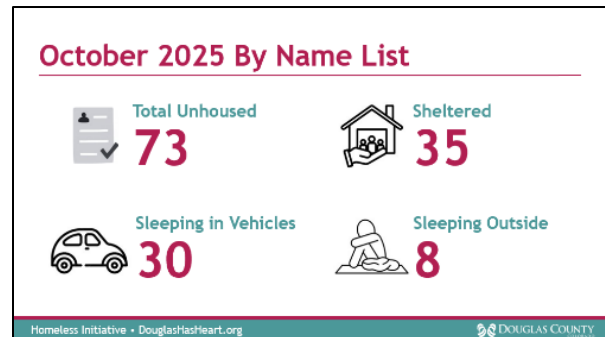


Supported through funding from the City of Aurora, Arapahoe County, Adams County, and Douglas County, the 13-acre facility is designed to provide comprehensive services, including emergency shelter, wraparound case management, supportive resources, and transitional housing for individuals experiencing homelessness. The facility will begin accepting participants on November 17.

- **HEART Success Story** – During the Summer Point-in-Time Count in July 2025, HEART Navigators met a woman and her dog who had been living in her vehicle for years. Despite her difficult circumstances, she remained optimistic and determined to find stability. The team learned she was a veteran who had not yet been connected to regional resources for housing support. The HEART Navigator referred her to Rocky Mountain Human Services, where she was quickly connected with a case manager. With guidance and encouragement, she began the process of applying for a housing voucher while working diligently to provide all necessary documentation.

In October, she was approved for a HUD-VASH voucher, and on November 4 she signed the lease for her new apartment. After months of uncertainty, she and her dog finally have a safe and stable home. She continues to work closely with her case manager to maintain her housing and build a foundation for long-term stability. Her story is a testament to resilience, teamwork, and connection.

Community Outreach

- **Seniors' Council of Douglas County** – The Terra Bluffs Senior Living Facility in Parker hosted the November 6 Seniors' Council meeting. Twenty-four attendees learned about the benefits of inpatient rehabilitation centers and how specialized programs can help older adults regain strength, mobility, and independence after injury, illness, or surgery.
- **2025 Fall Dounad** – The Fall 2025 Dounad event on October 25 focused on helping older adults throughout Douglas County. Following kick-off events in Castle Rock, led by Mayor Jason Gray, in Parker led by Mayor Joshua Rivero, and Highlands Ranch led by Commissioner Abe Laydon, more than 133 volunteers dispersed across the county to assist homeowners with much needed minor exterior repairs and yard work.

- **DC Cares** - Since October 1, 2024, DC Cares has assisted 17 unique households through a combination of rental assistance, emergency shelter, and case management services. Just over \$48,000 has been provided in rental support to help families maintain stable housing, while an additional \$7,000 has been used for emergency hotel placements for those without immediate shelter options.



In addition to financial assistance, the program has delivered more than 91 hours of case management. These sessions have helped participants access resources, navigate housing challenges, and work toward greater independence. DC Cares continues to offer both short-term support and guidance that helps households move toward longer-term stability.

- **Housing Stability Program (HSP)** - Since April 2025, the HSP has supported five households through the use of Homeless Resolution Program (HRP) funds. Just under \$27,000 has been spent to help prevent evictions, provide case management, and support ongoing housing stability for these families. All five households are led by single mothers who are actively working to increase their income and address barriers to long-term stability.



One currently active household has continued to receive rental assistance and case management support, which has helped prevent homelessness and stabilize their housing situation. The individual recently relocated to a new unit within their housing complex and is becoming more established in a new job. In addition to maintaining employment, they are pursuing their GED and have begun building an emergency savings account, all of which are important steps toward improving financial security and independence.

Partner Engagement and Support

- **Celebrating 20 years of the Douglas County Youth Initiative (DCYI)** - In 2005, a group of visionary leaders asked a simple but powerful question: How can we better serve the children and families of Douglas County? From that conversation, the Youth Initiative was born.

Since then, DCYI has enriched the lives of more than 3,000 young people through programs that promote leadership, civic engagement, and support for families — from Youth Congress at the State Capitol to teen court mentoring, truancy court support, wraparound services, and the

None of this would be possible without the partnership of our local municipalities, school district, libraries, and countless community members who share in our mission. Together, we've built more than a program — we've built a promise: to engage, support, and believe in our youth. As we celebrate 20 years of the Douglas County Youth Initiative, we also look ahead — continuing our commitment to ensuring that every young person in Douglas County has the opportunity to learn, lead, and succeed. - **Integral Care Training** - On October 30–31, the County hosted Integral Care Training at Cherry Hills Community Church in Highlands Ranch. The two-day interactive training facilitated by Community Services and Manna Resource Center staff was designed to equip case managers with practical tools they can immediately apply in their daily work. Participants explored how to create effective case plans, apply executive function strategies, set meaningful goals with clients, and use trauma-informed practices to guide their approach. Fourteen case managers from local partner organizations attended and actively engaged in group discussions and role-play exercises, walking away with a toolkit of proven methods to strengthen their effectiveness, improve client outcomes, and enhance coordination within the community.



- **Metro Denver CoC Stakeholders Meeting** - On October 29, the Metro Denver Homeless Initiative (MDHI), in partnership with Community Solutions, hosted the 2025 Metro Denver CoC Stakeholders Meeting. DC staff joined stakeholders from across the Metro Denver region for strategic planning discussions. Together, participants explored short- and long-term regional priorities, strategies to strengthen a resilient homelessness response system, and opportunities for MDHI to continue supporting the region's collective goals.



- **Built for Zero Strategy Session** – On October 29, representatives from the seven Metro Denver communities came together for a Built for Zero (BFZ) learning session. The group reaffirmed its shared commitment to ending veteran homelessness and began coordinating efforts to address other key subpopulations, including families, youth, and single adults. Staff participated in the session to discuss each subregion's progress, priorities, and goals through 2027.



Open Space and Natural Resources

- **Learn about elk habitat and seasonal changes as you discover DuPont Open Space** - Explore the untouched woods, winding trails and scenic creekside scenery of DuPont Open Space in Sedalia this November. Join Agents of Discovery in a peaceful trek as you learn about the landscape and the herds of elk that call many areas of Douglas County home.

- **Aquatic Invertebrate Field Trip to the South Platte River with Open Space and Natural Resources** - At the end of October, the OSNR team partnered with Castle View High School to teach two Advanced Placement (AP) Environmental Science and Aquatic Biology classes. This was a two-day hands-on learning experience at the Chatfield Audubon Center along the South Platte River. This partnership, now in its 20th year, provides students with valuable, real-world exposure to Douglas County's natural ecosystems.



Each day, approximately 50 students participated in field activities focused on river system health. Students donned waders, entered the river, and collected aquatic organisms such as crawfish and mayflies. Students also studied water chemistry, calculated river-flow rate, and learned about the roles of indicators, endangered, keystone, and apex species within riparian areas. These habitats cover only about 2% of Colorado's landscape yet support a disproportionately high share of the state's plant and animal biodiversity.



- **Research and Demonstration Orchard at Hidden Mesa Open Space** - Hidden Mesa Open Space is a 1,200-acre property of grassland and scrubland habitat and the site location of the five-acre Research and Demonstration Orchard. In 2010, Open Space and Natural Resources (OSNR) received a \$120,000 Communities Putting Prevention to Work grant, administered through the Health Department with support from the Crooked Willow Foundation, to fund the orchard's initial development.



The orchard aims to research both traditional and innovative fruit and nut cultivators, and experiment with growing methods best suited to the Front Range climate. Over the past decade, OSNR staff and volunteers have conducted variety trials of lavender, herbs, and annual vegetables. Today, the orchard includes a production garden, native pollinator bed, free-range chickens, and the team is exploring new fruit and vegetable propagation techniques. Colorado State University (CSU) and CSU Extension also provide technical expertise for research and development. The orchard has over 60 active Douglas County volunteers, with 20-25 participating every Tuesday. Together with volunteers from CSU Extension Master Gardeners, they contribute over 2,000 hours annually.

All produce from the orchard is donated to the Parker Task Force, a volunteer-run food bank and counseling center serving Parker, Elizabeth, and Franktown. In 2025, donations exceeded 3,100 pounds, a 20% increase from 2024 (see chart for a detailed breakdown). Since 2012, OSNR has donated a total of 40,000 pounds of produce!

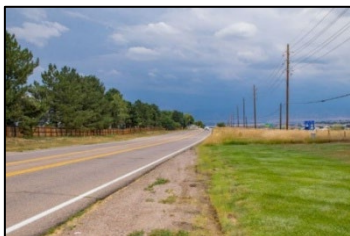

Public Works

Activity Report Oct 27 – Nov 14, 2025

Active Projects ([Cone Zone Webpage](#))

- **[County Line Road Widening and Reconstruction](#)** – Construction on County Line Road began in September.



On Monday, Oct. 6, 2025, traffic was shifted on County Line Road between University Boulevard and Clarkson Street. With this traffic shift, westbound traffic shifted to the south, and eastbound traffic remains shifted to the south. Be aware of crews working on the north side of County Line Road, as well as trucks and construction equipment in the project vicinity. This lane shift is scheduled to be in place until approximately August 2026. Beginning in late December 2025, motorists should anticipate a full closure of County Line Road from Clarkson Street to the U-Haul business access area. The closure will last approximately 100 days, giving crews time to import dirt for construction at Lee Gulch.

Since 2019, Douglas County has worked with partners to advance the final design, acquire right-of-way, and prepare utility relocation design for a major water line located within the project area. Douglas County is partnering with the Denver Regional Council of Governments, City of Littleton, and City of Centennial to fund the project.

- **[Highlands Ranch Drainage Projects](#)** - The Highlands Ranch Small Storm Sewer UV-CIPP Lining projects has recently progressed to additional locations. Recently, the contractor began conducting UV lining on storm sewer at the corner of Summit View and Heatherwood, 9275 S. Broadway and 8800 S. Broadway. These projects are anticipated to be completed on December 31, 2025, weather dependent.



- **Hilltop Road (Legend High School to Crest View Drive) Improvements Project** – For segment 1 of this

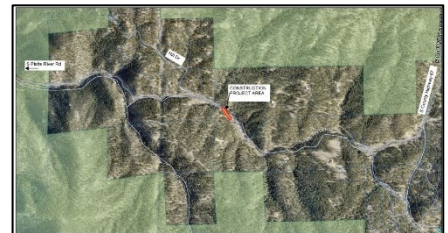


project, the construction began on April 16, 2025, and the contractor began implementing public notifications on message boards. This is the first of three projects planned over the next few years to reconstruct and widen the Hilltop Road and Singing Hills Road corridors. The project has a 16-month completion date and is anticipated to be finished in September 2026. Phase 2 of Construction is anticipated to begin in 2027; and will take 9 to 12 months to construct. Phase 3 of construction is anticipated to begin in 2029 (pending funding); and will take 12 to 18 months to construct.

There have been questions from citizens about the new roundabout construction at the intersection of Crestview Dr and Village Rd on Hilltop Rd, which will eliminate the existing two-way stop-controlled intersection. Here is the map: [Roundabout Rendition/Map](#).

- **I-25 Douglas County Monument Signs** – Cushing Terrell has begun producing construction plans for the sign near Lincoln Ave. Cushing Terrell has RTD contact information and will begin coordination on the overpass signage. County staff also received feedback from CDOT on the location of the southern signage and the consultant will now move forward with the design of a sign north of exit 163. Next steps include revisiting the design of the sign for the south end, continuing to reach out to RTD regarding the pedestrian bridge sign, and applying for CDOT approval of the north site near Lincoln Ave.

- **Pine Creek and Highway 67 Culvert Replacement Project** - Two culverts on Pine Creek Rd and three culverts on Douglas County Highway 67 need to be replaced. The existing storm culverts vary in size from 36" diameter to 48" diameter and are made of metal. We are anticipating that this work will occur Fall 2025 – Spring 2026. These culvert replacements will have roadway impacts and travelers to the area should expect long delays.



- **Kendrick Castillo Way / Plum Valley Lane Intersection Signal Project** – This project consists of installing a new traffic signal and making upgrades to meet current ADA requirements at the intersection of Kendrick Castillo Way and Plum Valley Lane. Traffic signal and roadway construction started on May 5, 2025, and is anticipated to be completed in mid-November 2025.

- **Grigs Road Paving Project – Phase 2** - RS&H was selected as the design consultant for phase 2 of the Grigs



Road project. Phase 2 will start where phase 1 ends, near the East-West Trailhead Parking Lot and will continue north onto the existing concrete road. The project includes realignment of the road, drainage improvements, a parallel pedestrian trail, and asphalt paving. A kick-off meeting was held on September 15th with the consultants, County staff, Highlands Ranch Metro District staff and Highlands Ranch Community Association staff. The consultant will now begin survey work.

- **Highlands Ranch Pkwy Reconstruction, Broadway to Burntwood** - Olsson submitted the 30% design, the geotechnical report, and a cost estimate for the project. A design review is scheduled with Olsson and County staff on October 23rd. After incorporating the County feedback into their design, Olsson will submit 90% plans. The project is planned for construction bidding in early 2026.

- **Quebec and Park Meadows Drive Intersection Improvements** – Basis Partners presented an initial review of the concept design on October 21st and will deliver the concept design as well as cost estimates in mid-November. The concept design includes improvements from C470 to the lighted intersection south of Park Meadows Dr. The first phase of work is planned for 2026 and may include retiming of signals and upgrades to signs and striping. Basis is also working on a proposal to provide final design for a larger project that includes reconfiguring the lanes, median, and sidewalks as well as reconstruction of the pavement continuing south to Palomino Pkwy.

- **[C-470 Trail and University Blvd Pedestrian Grade Separation Project](#)** - Douglas County and CDOT are



partnering on advancing the construction of a new bridge to improve pedestrian and cyclist safety by eliminating the need for users of the C-470 Trail to cross University Blvd at-grade. This currently requires four separate roadway crossings across eight lanes of traffic. The proposed crossing will also improve traffic operations, since the numerous bicyclists and pedestrians currently crossing at-grade, adversely impact signal progression along University Blvd and traffic entering or existing the C-470

ramps, especially on the weekends when trail use is highest. In order to build the new pedestrian bridge, crews have built a [pedestrian detour](#). Cyclists will be required to dismount and walk through the area. This detour will remain in place throughout the project, which is anticipated to be completed on or before December 31, 2025.

- **2023 Bannock LID** - The design consultant, TST, is working on the design, with a preliminary design expected by the end of the year. County staff have reviewed the initial roadway design and provided feedback. Once the preliminary design is complete, financing will be executed, and plans will be prepared for bidding.



- **2025 Pavement Management Projects**

- The 2025 Pavement Management projects under contract currently total \$17,598,589.62 with \$16,874,111.93 spent; work is 96% complete.
- The **2025 Sidewalk Repair Project** has been awarded a contract amount of \$2,635,150.00. Additional work has been added to the contract, and the current amount is \$4,141,104.92. The sidewalk project is 83% complete, based on funding. A change order in the amount of \$633,454.92 was approved by the Board on September 2nd. Concrete repair work will continue the week of September 15th with pavement repairs throughout Highlands Ranch.

- **2023 Spring Canyon LID** – The design consultant, TST, is working on design work and 25% plans are anticipated in early October. The geotechnical design report has been reviewed and is being incorporated into the design. TST has begun the CDPHE approval process for the proposed lift station. The county has received rough construction cost estimates as well as a proposal for final design work and the project is still on schedule for mid-2026 construction bidding. TST will begin reaching out to property owners in November to discuss design considerations.



- **Country Club Drive 2025 LID (Group 10) CI 2025-015:** A ballot measure regarding the proposed Group 10 Local Improvement District (LID) was included in the general election held on November 4, 2025. Eligible lot owners within the district who are registered Colorado voters participated in the election to decide whether the LID should advance to the next phase. A majority vote in favor was required for the project to

proceed. The Douglas County Elections Office has confirmed that the LID ballot measure was approved by eligible voters.

- **Advertisement for Final Settlement for Hess Road over Wildlife Crossing Project and Bridge Improvements, Douglas County Project Number CI 2024-022**, will be published in the News Press on November 20, 2025 and November 27, 2025. Final Construction Settlement for Elite Surface Infrastructure will be December 20, 2025.

Community Development

Historic Preservation

- **International Archaeology Day** - The Douglas County History Repository attended International Archaeology Day on October 18 at Red Rocks Amphitheatre. Douglas County History Repository and Historic Preservation Board hosted a big booth with a mini pop-up museum inside for people to enjoy artifacts from the Metzler Ranch. All artifacts were focused on the dairy operations at the ranch. Staff and volunteers engaged with interested citizens and met several kids who are a part of the Lego League. The Lego League's theme this year was to focus on archaeology, and the kids were creating robots to help archaeologists find artifacts in the ground.

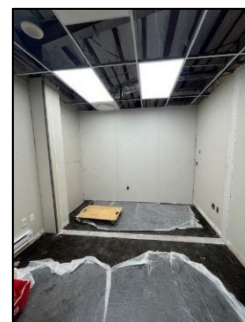

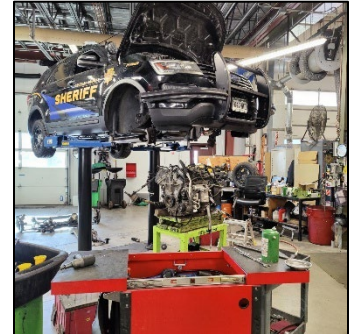

Completed IT Projects

- **Cybersecurity Awareness Month for County Employees** - October's Cybersecurity Awareness Month campaign engaged employees through a retro 8-bit-themed adventure, challenging them to "level up" their defenses each week against digital villains. Through quizzes, practical tips, and raffles, the campaign increased awareness of key security risks, including phishing, social engineering, and ransomware. Participation was strong across all levels, reinforcing our culture of vigilance and cybersecurity readiness.



- **Delivered Technical Support for the County Board of Equalization (CBOE)** - From August 1 to November 4, the IT Department supported the County Board of Equalization (CBOE) appeals process, with a focus on ensuring seamless phone and teleconference hearings. Alongside providing technical support, IT also delivered a new business application to facilitate the process. This combined effort ensured that appeal hearings were efficient and accessible, allowing participants—including appellants, board members, and county representatives—to engage in virtual proceedings smoothly and without technical interruptions.
- **Provided Technical Support for November's General Election** - From October 25 to November 5, the IT Department provided technical support to the Elections Team at the Voter Service and Polling Centers (VSPC). Their role was to ensure a secure, efficient, and smooth voting process by providing on-site technical support, troubleshooting, and resolving any issues faced by the Elections Team, judges, and poll workers.

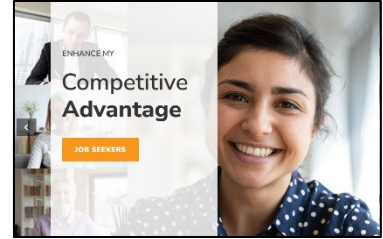

Arapahoe/Douglas Works!

Successes/Highlights:

- **Credentialing for Success:** A Douglas County Employment First participant, RK, entered the program with a PhD in Astro Engineering and a strong set of job-ready skills. Despite securing multiple interviews, he struggled to receive job offers and identified the lack of a Project Management Professional (PMP) certification as a potential barrier.
 - Through Employment First, he received funding to complete PMP training through the Project Management Academy, with certification expected in August 2026. Shortly after beginning the training, he was hired by Space Lab Technologies as a Senior Project Manager. His employer noted that his pursuit of the PMP credential was a key factor in their hiring decision.
 - Now earning \$77 per hour, he has regained financial independence and is able to support his family. He expressed deep gratitude for the support and funding provided by Employment First, which helped him become more competitive in a highly specialized field.



- Business Services is working with Advent Health to develop a **surgical tech Registered Apprenticeship Program**. Hospital locations include Douglas County.

- The **Colorado Apprenticeship Hub**, under the direction of the Arapahoe/Douglas Workforce Development Board, announced \$3 million in grant funding through the Colorado Apprenticeship Incentive (CAI) Grant. This funding supports the development and expansion of Registered Apprenticeship Programs (RAPs) and high-quality pre-apprenticeship programs across Colorado. Approximately 20–30 grants will be awarded through a competitive process, with individual awards up to \$150,000.

- Arapahoe/Douglas Works! filled the **Workforce Specialist for the Homeless Veteran and Reintegration Program (HVRP)**. He is well into his onboarding and is starting to conduct outreach for the program. Arapahoe/Douglas Works! will begin receiving referrals for the program within the next couple of weeks.



Events/Workshops

- CEED information sessions are occurring in November with an application window opening in December. CEED is for [businesses to apply](#) for funds to upskill current employees and to avert layoffs by reskilling employees.
- Arapahoe/Douglas Works! started the first cohort for the **Adult Basic Education and Literacy (AELA) grant**. Students interested in improving their digital literacy skills before starting their GED journey are working on obtaining the three NorthStar Digital Literacy certificates as a group.



Commissioner Work Sessions – October 27, 2025

- **Transportation Plan Update** – The Board was briefed on the Douglas County 2050 Transportation Plan. The plan, updated every five years as part of the County's comprehensive plan, serves as a strategic guide for transportation investments and project prioritization. Public engagement, which included over 1,000 survey respondents, identified the top three transportation challenges as congested corridors, managing growth,

and maintenance of existing roads. Correspondingly, residents prioritized adding regional roadway capacity, expanding public transit, and increasing maintenance. The Plan outlines a fiscally constrained list of projects and the success of the projects will be dependent on future funding. A lengthy discussion was had on the process, public engagement feedback, projects, timeline and funding. The Plan will be presented to the Planning Commission for approval in December.

- **OEM Update** – Office of Emergency Management (OEM) presented a series of strategic proposals aimed at shifting Douglas County's wildland fire management strategy from a primarily reactive footing to a proactive model of community resilience. The proposals, framed as "the first page of the next chapter in wildland fire management," address what is identified as the county's "number one natural hazard risk." The presentation detailed three core initiatives: Helitack Hangar, Wildfire Mitigation Program Expansion, and Prescribed Fire Program with a pilot project a Spruce Meadows Open Space in November.

Helitack Hangar:

Motion – Approval to add \$4,840,000 to the 2026 proposed budget for the Helitack Hangar Project, as presented. Passes 3-0.

Wildfire Mitigation Program Expansion:

Motion – Schedule a future detailed discussion to determine the final funding amount. The Board expressed strong consensus in support of the proposed strategic direction presented. However, the requested funding would draw from the General Fund that may have other competing requests. Passes 3-0.

Prescribed Fire Program:

Motion – Support the prescribed burn plan and direct staff to proceed with its implementation with potential to include burns each fall and spring in the future. Passes 3-0.

Motion #2 – Direct the Development Director to work with legal on changes to county regulations related to construction defects per discussion with the Development Director to work with the and County Attorney on an ordinance and bring forward to the County Commissioners for first reading and the first opportunity. Passes 3-0.

- **Community Services Briefing** – The Board was briefed on the following topics:

2026 DD Mill Levy Funding – Staff was previously directed to assess the DDML allocation and identify opportunities to provide funding for housing with supportive services projects that benefit individuals with Intellectual and Developmental Disabilities (IDD). Staff reported that they have consulted with Developmental Pathways and community partners and presented a proposal to fund \$2.5 million over three years to address the significant need for affordable housing combined with associated supportive services for the IDD population. The County's existing grant application process will be used to offer a competitive and transparent approach. Funding the grant will take \$850,000 annually from the DD Mill Levy budget,

however, Development Pathways annual allocation will not be affected. Discussion also included the timeline for the application process.

Motion – Direct staff to proceed with the recommendation presented. Passes 2-0. Commissioner Laydon was absent.

Link on Demand – The Board was updated on the continued success of the current service in Highlands Ranch/Lone Tree, survey results, and future expansion plans to the east and south. Parker Town Council has authorized \$250,000 in its 2026 budget to partner in the expansion of the service to Parker and an IGA will be developed. Staff reported that expansion plans to Castle Pines and Castle Rock have challenges due to the establishment of URA's in those areas. Discussions are expected to continue with those jurisdictions. Also, a key component of the expansion strategy is securing matching funding from RTD.

2025 Fall Dugnad Event – An update on the event was presented.

- **Human Services Updates** - Updates included current programs, primarily focusing on the impact of a government shutdown on Supplemental Nutrition Assistance Program (SNAP) benefits and the challenges this poses for approximately 10,400 SNAP recipients in Douglas County, the resulting strain on local food banks, and the County's strategy to monitor and potentially support these food banks with financial assistance. Recent HR1 changes to SNAP requirements, including work mandates for able-bodied adults, was also discussed. Additionally, The Board was provided an overview of the Department's \$60 million budget and new child abuse and neglect reporting legislation and progress regarding the establishment of crisis stabilization units and an update on the timeline for the office relocation to Lansing Circle.

Commissioner Work Sessions – November 10, 2025

- **Zebulon – Executive Session – No Notes**
- **Developmental Disabilities Mill Levy Funding Recommendations** – The DD Mill Levy Advisory Council presented its recommendations to allocate a budget of \$500,710 to 28 eligible and qualified applicants. A total of 43 applications were received totaling \$1,635,735. The criteria used to evaluate the applicants was provided and a lengthy discussion ensued. The Board directed staff to bring the recommendations forward to the December 9th Business Meeting for formal approval and a check presentation ceremony is planned for that time as well.
- **Energy and Carbon Management Commission (ECMC) Notice of Hearing – Pooling Order** – The Board was briefed on a notice of hearing from the ECMC and staff provided the background on the notice that concerns county-owned mineral rights. The Board concluded that no action is required. They will not appear at the ECMC hearing, as the Pooling Order is expected to be approved administratively in early December, so they took a position to do nothing at this time.

Commissioner Administrative Meeting – November 10, 2025

- **Entryway Signs Update** - Significant progress was made on the county's gateway signs. The North sign design (I-25 & Lincoln) is finalized and ready for formal submission to the Colorado Department of Transportation (C-DOT). For the South sign, the board approved a new location at the Palmer Divide Avenue interchange, driven by environmental and cost considerations. The board selected a horizontal design (Option 1) for the South sign to preserve the County motto and ensure effective lighting, directing staff to proceed with this plan. A formal resolution will be presented to the Commissioners for approval at the December 9th Business Meeting, to be included with the required submission to CDOT for its review.
- **Douglas County Open Space Camping Update with Wildfire Risk** - Following a directive to find a low-wildfire-risk camping location, staff presented an analysis based on Colorado State Forest Service data. All properties west of I-25 were eliminated due to high fire risk. Three properties on the eastern side of the

County—in the vicinity of Bayou Gulch Regional Park, Hidden Mesa, and Prairie Canyon—were identified as having low-to-moderate risk. After presenting the three county-owned properties, staff indicated that another property, not currently owned by the County, might be the most appropriate site among all options considered. The discussion concluded with the board moving into an executive session to discuss this potential fourth site.

Motion – Approval to pursue the transaction on the property discussed in executive session.

- **Boards and Commissions** – Staff provided a comprehensive update on the status of various boards and commissions appointments, reappointments and vacancies, and reported that contact had been made with all members whose terms and up for reappointment in January with positive results. Discussion included concern over Parks Advisory Board challenges because of quorum issues and a recommendation was made to fill one of the vacant seats in District 1.

Motion – Appoint Kristy Thomas to the Parks Advisory Board for District 1. Passes 3-0.
